DERBYSHIRE AND NOTTINGHAMSHIRE ELECTRIC POWER.

APPPLICATION is intended to be made to Parliament in the ensuing Session by the Derbyshire and Nottinghamshire Electric Power Company (hereinafter called "the Company") for an Act the principal subject matters of which are as follows:—

Additional capital borrowing powers in respect of authorised and additional capital, redeemable securities and further powers in relation to capital and the issue and raising thereof.

To provide for increase of Company's capital and borrowing powers by Special Order and empower the Electricity Commissioners and Minister of Transport to make and confirm such Orders.

Provisions as to meetings dividends registers voting notices contracts directors secretary and auditors pensions allowances &c.

Confirmation of purchase of the lands hereinafter described and power to Company upon such lands to maintain carry on work use enlarge alter and renew the Company's existing generating station and works and to exercise other powers in relation thereto. The said lands are:—

Certain lands adjoining the River Derwent containing 20 acres or thereabouts situate in the Parish and Borough of Derby on which lands the existing generating station of the Company known as the Spondon Power Station is situate.

Abstraction of water from River Derwent for condensing and other purposes.

Confirmation (with or without modification) of agreement dated 12th April 1927 between Company the 9th Earl of Harrington and others and of the acquisition by Company of rights or easements of constructing and maintaining on banks and bed of River Derwent and mill stream forming part thereof certain erections and works and of controlling and managing weirs on said river and mill stream and sluices at Borrowash Mill and of access to said weirs and sluices and the supply of electricity by Company to occupier of premises of said Earl and powers to carry agreement into effect.

Acquisition of lands by agreement power to persons under disability to grant easements erection of cottages dwelling houses offices and other buildings power to hold &c. lands and to provide that in event of owner or occupier of land over which Company propose to place

electric lines failing to consent or attaching conditions thereto the Minister of Transport may authorise placing of line pending consideration by Minister of giving or withholding of his consent under Section 22 of the Electricity (Supply) Act 1919.

Power to lay down maintain repair alter and use pipes for conveying water and other materials matters or things to or from generating stations or works belonging leased to or worked by Company and agreements with respect to construction &c. of electric lines pipes works appliances and apparatus on bed banks and foreshore of rivers &c. or affecting railways bridges and other property.

Powers of supplying electricity in bulk in areas contiguous to Company's area of supply or Company's area in relation to undertakings transferred to or authorised by Provisional or Special Orders granted to Company or for purposes of undertakings managed by them, to apply for Provisional Special or other Orders, to acquire undertakings of other authorised undertakers within or partly within or adjoining any such area and extend period for purchase or re-purchase by local authority of any undertaking transferred to Company and make other provisions in respect thereof, to acquire lease maintain alter or dispose of generating stations substations and works, to issue securities in consideration for transfers &c., agreements as to use management or maintenance of generating stations main transmission lines and works of other authorised undertakers and provisions incidental thereto and to increase amount which Company may subscribe and lend to other companies &c.

Breaking up and interference with streets and exercise of powers within and beyond area in which Company are or may be authorised to supply electricity, mains in private streets, apparatus fittings &c., offices and showrooms, entry upon premises use of works apparatus transformers &c. provisions as to supply of electricity, prevention of improper use, cutting off and discontinuance of supplies notices by consumers, recovery of expenses, the imposition and recovery of penalties application of funds, agreements with local authorities &c., incorporation application amendment or repeal of Acts and Orders and other purposes.

Printed copies of the Bill will be deposited in the Committee and Private Bill Office of the House of Commons on or before the 17th December next and on and after the 21st December next a copy of the Bill may be inspected and copies may be obtained at the price of three shillings and sixpence per copy at the offices of the undermentioned Parliamentary Agents.
