## GAS LIGHT AND COKE COMPANY.

NOTICE is hereby given that application is intended to be made to Parliament in the Session of 1928-9 by the Gas Light and Coke Company (hereinafter called "the Company") for leave to introduce a Bill (hereinafter called "the Bill") of which the principal subject matters are as follows:—

Transfer to and vesting in the Company of the undertakings of the Grays and Tilbury Gas Company and the Pinner Gas Company Limited and dissolution of those companies and other provisions relative to such transfer and vesting; continuance of certain provisions of Acts and Orders relating to the transferred undertakings and repeal of the remainder of such provisions including certain provisions relating to the purchase and working up of products the purchase of other residual materials and the manufacture of chemicals; provisions as to the price to be charged by the Company for gas supplied in the areas of the Companies whose undertakings are transferred including powers of charging differential prices; provisions as to the declared calorific value of the gas to be supplied by the Company in the said areas.

Power to the Company to borrow money in respect of Ordinary Stock and Preference Stock to be issued as consideration for the transfer of the said undertakings.

Power to Company to purchase compulsorily lands in the Metropolitan Borough of Shoreditch, in the County of London; in the County Borough of West Ham, in the County of Essex; in the Urban District of Willesden, in the County of Middlesex; in the Parish of Wyrardisbury, in the Rural District of Eton in the County of Buckingham; and in the Urban District of Egham in the County of Surrey.

Power to the Company to manufacture and store gas and work up and convert residual products etc. on certain lands in the Metropolitan Boroughs of Shoreditch and Woolwich in the County of London; in the County Borough of East Ham and the Urban District of Barking Town in the County of Essex; in the Parish of Wyrardisbury in the Rural District of Eton in the County of Buckingham; and in the Urban District of Egham in the County of Surrey.

Powers to the Company of laying mains or pipes in or under land (whether within or beyond their limits of supply for the time being) including railways, canals, inland navigations, docks and harbours; power to the Company to alter the position of pipes or wires of other bodies or persons and to other bodies or persons of altering mains or pipes of the Company; provisions as to testing etc. of the calorific value of gas supplied by the Company where the whole or part of the moisture contained therein has been extracted; power to the Company to lay mains etc. in streets, roads, footpaths and highways outside their area of supply for the time being for conveying gas to or from severed or intersected portions of such area; additional powers of acquiring lands by agreement; increase of

remuneration of the Directors of the Company; amended provisions as to sale of lands by the Company; additional powers of entering upon premises for certain purposes.

Incorporation repeal and amendment of Acts and Orders.

So far as relates to the urban district of Willesden with the Clerk to the Willesden Urban District Council at the Town Hall, Dyne Road, Kilburn, N.W. 6;

So far as relates to the County Borough of West Ham with the Town Clerk of that County Borough at the Town Hall, West Ham, E. 15;
