

Lands comprising 74 acres 2 roods 10 perches or thereabouts in the Urban District of Llanfrechfa Upper and known as Blaen Bran Farm.

As relates to the Parish of Llanfrechfa Lower with the Clerk to the Parish Council at her office at The Laurels Ponthir near Newport Mon.

LONDON AND HOME COUNTIES JOINT ELECTRICITY AUTHORITY.

NOTICE is hereby given that application is intended to be made to Parliament in the Session of 1928-9 by the London and Home Counties Joint Electricity Authority (hereinafter referred to as "the Authority") for an Act of which the principal subject matters are as follows:—

1. The transfer to the Authority of all rights conferred upon or vested in local authorities to purchase the whole or part of electricity undertakings of authorised undertakers wholly or partly comprised in the London and Home Counties Electricity District (hereinafter called "the district"), including rights under the Electric Lighting Act 1888, any Special Act or Provisional or Special Order, or any deed or agreement of transfer and including rights to resume possession on the expiration of a period or on service of a notice. The undertakings referred to are authorised by the Acts and Orders mentioned in the notice referred to in the final paragraph hereof.

2. The transfer to the Authority of benefits conferred by and the exercise by them of all rights under any such Act Order deed or agreement as is hereinbefore referred to and the exercise by them of all powers appertaining to the several undertakings acquired by them and the supply of electricity either in bulk or in detail for all purposes within the areas of supply of such undertakings notwithstanding the provisions contained in any Acts or Orders restricting the powers of a Joint Electricity Authority or otherwise.

3. The extension of the district to comprise the whole area of supply of the undertaking of any company part of which is already comprised in the district including the undertakings authorised by the following Orders:—

Chesham Electric Lighting Order 1901, Chesham Electric Lighting Order 1907, Chesham Electric Lighting (Extension) Order 1909, Chesham Electricity (Extension) Special Order 1928, Dorking Electric Lighting Order 1897, Dorking Electricity (Extension) Special Order 1927, Horley and District Electricity Special Order 1925, Horley and District Electricity (Extension) Special Order 1926, Wickford and District Electricity Special Order 1923.

The areas so proposed to be added to the district are situate in the counties of Hertford, Buckingham, Surrey, Sussex, and Essex and include the following:—

the urban district of Great Berkhamstead, the parishes of Great Berkhamstead Rural, Northchurch, Little Gaddesden and Nettle-den in the rural district of Berkhamstead, the parishes of Ashley Green, Chesham Bois, Latimer, Lee, Chartridge, Great Missenden, and Little Missenden in the rural district of Amersham, the parish of Great Gaddesden in the rural district of Hemel-Hempstead, so much of the parishes of Wotton and Abinger in the rural district of Dorking as is comprised in the area of supply under the Dorking Electricity (Extension) Special Order 1927, the parishes of Horley and Burstow in
