## BIRMINGHAM CORPORATION (GENERAL POWERS).

NOTICE is hereby given that application is intended to be made to Parliament in the Session 1928-9 by the Lord Mayor Aldermen and Citizens of the city of Birmingham (hereinafter called "the Corporation" and "the city" respectively) for an Act of which the principal subject matters are as follows:—

1. The construction of street improvements in the city, comprising widenings of Ladypool Road, Summer Road and Gravelly Hill North, and a new street commencing at Six Ways, Erdington and terminating by a junction with High Street, Erdington.

2. Further provisions with reference to the tramways trolley vehicle and omnibus undertaking of the Corporation including provisions relating to the manufacture by the Corporation of omnibuses and trolley vehicles, and the construction of a tramway in the city in Summer Road and in the proposed new street above referred to.

3. Acquisition of land for the purposes of the Bill and the modification of the Lands Clauses Acts, and further powers for the acquisition, retention, development and disposal of lands.

4. Extension of limits for the supply of water by the Corporation to include the parishes of Fillongley, Great Packington, Lea Marston, Little Packington, Maxstoke, Nether Whitacre, Over Whitacre and Shustoke in the rural district of Meriden and the parish of Tanworth in the rural district of Solihull, all in Warwickshire and so much of the parish of Cofton Hackett in the rural district of Bromsgrove in Worcestershire as is not already within the Corporation's limits and the parish of Frankley in that district; the extension of the limits of the East Worcestershire Waterworks Company for the supply of water to include the parishes of Alvechurch and Beoley in the said rural district of Bromsgrove, the confirmation of an agreement with the last named Company, and further provisions for the protection of the purity of water to be supplied by the Corporation and in regard to the supply of water by them.

5. Further provisions with regard to streets, buildings and sanitary matters including building lines, means of escape from buildings in case of fire, modification of Housing Act, 1925, the fixing of the rent of rooms in working class houses and other matters. 6. The extension of the Town Planning Act

6. The extension of the Town Planning Act 1925 to lands wholly or partly developed subject to the modifications indicated in the intended Act.

7. Further provisions as to water-courses and streams.

8. The regulation of the sale of coke and other fuel.

9. Further powers in regard to the Savings and Housing Bank including the establishment of branch banks in areas adjoining the city.

10. The borrowing of money for the Corporation's water undertaking and for the purposes of the Bill, the issue of bonds, the application of revenues of undertakings, the formation of reserve and consolidated loans funds, the use of money in funds, the gas and water annuity registers, the formation of a special fund to include money received by way of gift or legacy or raised by rates, and other financial matters.

11. The substitution of appointed auditors for the city auditors.

12. The hearing of licensing appeals by quarter sessions of the city instead of county quarter sessions.

13. Further powers for Corporation and the modification of their existing Acts, including the exemption of assurances from restrictions under Mortmain Acts, amendment of the enactments relating to the Minister's fees in the Yardley Burial Ground, the formation of a fire brigade superannuation fund and the amendment of the provisions relating to members of the fire brigade, superannuation of the teachers in the Monyhull Colony of the Birmingham Board of Guardians, the provision of medicated and other baths and appliances in wash-houses, the contribution towards expenses of the British Industries Fair, the establishment of bureaux for supplying information and the application and amendment of existing enactments.

14. To make further provision in regard to public weighing machines, liability for damage to street lamps, the extension of the Town Police Clauses Act 1847 and byelaws thereunder to motor vehicles standing or plying for hire, the authentication of licences and other matters.
