7. The acquisition by the Corporation of lands in the City and parish aforesaid for the purposes of or connected with the proposed waterworks and street works and for other purposes to be specified in the Bill; the breaking up of and interference with streets.

8. The exemption of the Corporation from the operation of Section 92 of the Lands Clauses Consolidation Act 1845 in certain cases and the enactment of certain amendments of the Lands Clauses Acts in their application to the Bill and of special provisions for assessing compensation for lands acquired under the Bill; provisions for empowering the Corporation to erect buildings on and to develop lands acquired by or belonging to them under statutory powers and to let such lands on building leases and to advance money or assist financially purchasers or lessees of such lands; further provisions as to the retention and disposal of surplus lands.

9. The enactment of further provisions as to the acquisition by the Corporation of lands by agreement for the benefit of the City and for the exercise of their powers and duties.

10. The extension of the time for the acquisition by the Corporation of lands referred to in the Chester Order 1926.

11. The enactment of further provisions with regard to the electricity undertaking of the Corporation and the supply of electricity hy them including provisions as to maximum power to be demanded; the supply to premises partly outside the limits of supply; entry of premises; wrongful use of electricity; erroneous registration of meters; construction of sub-stations &c. under roads and electric lines in streets not dedicated to public use; the use of transformers; the supply of fittings; byelaws as to wires, apparatus and fittings and for preventing fire; the use of lighting current supplied for power; as to notice to discon-tinue supply; agreements for supply of electricity in bulk; altering the guarantee to be given for supplies beyond the city; cutting off. of supplies; purchase of other undertakings; and other matters.

12. The enactment of further provisions with regard to streets, rows and stalls, buildings, hoardings, advertisements, facia boards, street lamps, sewers, drains, infectious disease, sanitary matters, common lodging houses, slaughter-houses, food, the registration of manufacturers &c., of ice-cream and potted meat, traffic in streets, hackney carriages, omnibuses, parking places, the licensing of drovers and city guides, and other police matters; and provisions regulating or restricting the right to break up streets.

13. The running of omnibuses by the Corporation within the City and outside the City within a radius of ten miles of the Town Hall, Chester; the enactment of all necessary and usual provisions with regard to the running of such omnibuses by the Corporation, including provisions as to fares and charges, working agreements and the acquisition of lands by agreement; the abandonment of the tramways of the Corporation; the enactment of provisions for preventing competition with tramways or omnibuses of the Corporation.

14. The enactment of further provisions with regard to the markets undertaking of the Corporation, including provisions for the increase

of stallages, tolls and charges; the sale, leasing or alteration of markets and market halls; the removal of market halls; the erection of offices, shops &c. in connection with markets; the use of market places for fairs, for parking places for vehicles and for public and other meetings; power to take possession of stalls for non-payment of rent and power to exclude or detain diseased animals; provisions for enlarging and extending the powers of the Medical Officer to Veterinary Inspectors in regard to markets.

15. The provision of automatic weighing machines in markets, public baths and elsewhere by the Corporation; the control and examination of petrol pumps and automatic weighing machines.

16. The enactment of further provisions with regard to public weighing machines, including provisions for requiring the keepers of such machines to have their names written on their premises, penalties on such keepers for neglect to weigh or for unfairly weighing vehicles and their loads and for giving false tickets as to weight or otherwise committing or assisting to commit frauds.

17. The enactment of further provisions with regard to the sale of coke.

18. Prohibiting the deposit of refuse and materials upon, against or near to the city walls.

19. The enactment of further provisions with regard to public buildings, parks and baths including provisions for empowering the Corporation to exercise all the powers of the Public Health Acts in regard to Grosvenor Park and the Little Roodee, to lease the Little Roodee or use it as a parking place, to close the Little Roodee and footpaths thereon for certain purposes and periods, the provision of entertainments by the Corporation in buildings baths and parks and other matters; the letting of baths and their use for exhibitions &c.

20. The extension of the Town Planning Act 1925 to lands wholly or partly developed in the City, and also in the urban district of Hoole and the rural districts of Chester and Tarvin.

21. The enactment of further provisions for the control management and regulation by the Corporation of so much of the River Dee as extends from the City to the Iron Bridge at Aldford in the County of Chester and of traffic on that river, including provisions as to registration marking and licensing of vessels and boats; and fees payable on registration empowering the Corporation to make bye-laws for the regulation and management of the river and the navigation thereof; provisions as to the mooring of vessels and the removal of obstructions and provisions for requiring vessels to be navigated so as to avoid endangering persons or property.

22. Empowering the Corporation to establish information bureaus and to appoint persons who are not members of the Council to serve on the Development and Advertising Committee.

23. The establishment and maintenance by the Corporation of an aerodrome undertaking.

24. The borrowing of money by the Corporation for the purposes of the Bill and other financial matters including the provision of working balances, the use of funds for borrow-
