

ing, the issue of new classes of stock, the application of the various revenues of the Corporation, reserve funds, the audit of accounts, the authorisation of the payment of certain expenses by them, the collection of water and electricity charges, the establishment of a consolidated loans fund and other financial and miscellaneous matters.

25. The incorporation, repeal and amendment of Acts and Orders both general and local and the enactment of all incidental provisions.

Plans and sections of the intended works and plans of the lands intended to be taken for the purposes of the intended Act, together with a book of reference to the plans will on or before the 30th day of November instant be deposited for public inspection with the Clerk of the Peace for the County of Chester at his office, the County Offices, Northgate Street, Chester, with the Clerk of the Peace for the County of the city and county borough of Chester at his office, Abbey Gateway in the city, and a copy of so much of the said plans, sections and book of reference as relates to each of the several areas hereinafter mentioned will, on or before the said 30th day of November be deposited as follows:—

So far as relates to the city with the Town Clerk of the City at his office therein, so far as relates to the rural district of Chester, with the Clerk to the Chester Rural District Council at his office at 2, White Friars, Chester, and so far as relates to the parish of Upton by Chester, with the Clerk to the Upton by Chester Parish Council at his office at 68, Watergate Street, Chester.

Printed copies of the Bill for the intended Act will be deposited in the Committee and Private Bill Office of the House of Commons on or before the 17th day of December next.

#### DERBY CORPORATION.

NOTICE is hereby given that application is intended to be made to Parliament in the Session 1928-9 by the Mayor, Aldermen and Burgesses of the borough of Derby (hereinafter called "the Corporation" and "the borough" respectively) for an Act of which the principal subject matters are as follows:—

1. The construction and maintenance by the Corporation of the following river improve-

ment and sewage works (with incidental works) in the county of Derby:—

Work No. 1.—A River Improvement in the Borough, the Urban District of Alvaston and Boulton and the Parishes of Elvaston and Spondon (Rural District of Shardlow) commencing in the River Derwent at the boundary between the Litchurch and Osmaston Wards of the Borough and terminating in the Parish of Spondon, 35 yards from the western end of Borrowash Weir.

The said Work No. 1 consists of:—

(i) River Improvement A. A deepening widening and improving of the channel of the River Derwent in the Borough from the commencement of Work No. 1 to a point 50 yards east of the eastern boundary of London Road Recreation Ground.

(ii) Cut A. A river diversion or cut in the Borough, commencing at the termination of River Improvement A and terminating 40 yards north of the point at which the boundary of enclosure 607 on the 2500 Ordnance Map (1914 edition) of the Borough reaches the bank of the said river; and the stopping up of the existing loop of the river between the commencement and termination of Cut A.

(iii) River Improvement B. A deepening widening and improving of the channel of the River Derwent for a distance of 415 yards in the Borough commencing at the termination of Cut A. and terminating 35 yards southwest of the point at which the northern boundary of enclosure 603 on the said Ordnance Map reaches the said river.

(iv) Cut B. A cut across the base of the loop of the River Derwent opposite the Corporation's Sewage Disposal Works Pumping Station situate in the Borough.

(v) River Improvement C. A deepening, widening and improving of the channel of the River Derwent situate in the Borough, commencing at the termination of Cut B. and terminating 23 yards northeast of the point at which the northern boundary of enclosure 673 on the said Ordnance map reaches the bank of the said river.

(vi) Cut C. A cut across the neck of the loop of the River Derwent in which the gravel pits of British Celanese Limited are situate, wholly in the Borough.

(vii) River Improvement D. A deepening, widening and improving of the channel of the River Derwent, commencing in the Borough at the termination of Cut C. passing through the said Urban District of Alvaston and Boulton and the said Parish of Elvaston into and terminating in the said Parish of Spondon at the termination of Work No. 1.

Work No. 2.—A weir across intended Cut B. above described.

Work No. 3.—A set of sluices across intended Cut C. above described.

Work No. 4.—A line of sewer situate in the Borough, commencing in an existing sewer of the Corporation at a point 22 yards south of the commencement of Work No. 2
