public baths of the Corporation, Full Street, Market Place, Tenant Street, the Morledge, Cattle Market thoroughfare, the Derby Canal and the river Derwent;

(b) For the widening of Curzon Street and Abbey Street,—the premises known as 39, Curzon Street;

(c) For the extension of the highways depot of the Corporation,—the premises known as 53, Willow Road.

7. The stopping up of the existing bridleway or footpath from Alvaston to Spondon, from the commencement of street work No. 1 to the northern boundary of the lands of British Celanese Limited and the stopping up of Burghley Street and part of Boroughs Walk in the borough.

8. The erection of a town hall and other buildings upon the lands (a) referred to in paragraph 6 hereof; the letting of the whole or any part of such buildings; the erection of shops in connection with any such town hall or buildings as aforesaid and on other lands of the Corporation; the user of any part of the said lands (a) (which is not required for the purposes aforesaid) for the purposes of the markets undertaking, for a parking place and for other purposes.

9. The exemption of the Corporation from the operation of section 92 of the Lands Clauses Consolidation Act, 1845 in certain cases and the enactment of amendments of the Lands Clauses Acts in their application to the Bill and of special provisions for assessing compensation for lands acquired under the Bill; provisions for empowering the Corporation to erect buildings on, and to develop, lands acquired by, or belonging to them under statutory powers and to let such lands on building leases and further provisions as to the retention and disposal of surplus lands.

10. The increase of rates and charges for water supplied by the Corporation for domestic purposes and the enactment of further provisions with regard to the water undertaking of the Corporation, including provisions for the registration of plumbers and power to make byelaws as to water fittings.

11. The repeal of section 48 of the Derby Waterworks Act, 1848, and Section 24 of the Derby Corporation Act, 1890, relating to purchase by other authorities of portions of the water undertaking of the Corporation.

12. The enactment of further provisions with regard to the omnibuses and tramways of the Corporation, including provisions as to parcels and dogs, passengers' luggage, the reservation of cars, signs indicating stopping places and the restriction of the running of omnibuses in competition with omnibuses and tramways of the Corporation.

13. The enactment of further provisions with regard to streets and sanitary matters, including provisions as to exchange of parts of streets disused, culs de sac, byelaws as to alteration of streets, expense of privy conversion and the giving of information as to infectious disease.

14. The extension of the Town Planning Act, 1925, to lands wholly or partly developed.

15. The enactment of further provisions with regard to hackney carriages and street

traffic, including provisions as to insurance by hackney carriage proprietors, regulations for controlling traffic and as to stands and stopping places for omnibuses.

16. The extension of Orders under the Shop Hours Act, 1904, and the Shops Acts, 1912 to 1928, which are in operation in the borough as constituted prior to April 1928, to the areas added to the borough by the Derby Corporation Act 1927.

17. The recovery of penalties for offences in parks etc. of the Corporation outside the borough.

18. Power to increase superannuation and other allowances in certain cases.

19. The amendment of section 55 of the Derby Corporation Act, 1877, with regard to the user of markets and market halls by pedlars and hawkers.

20. The enactment of further provisions as to the appointment and duties of committees and sub-committees of the Corporation.

21. The borrowing of money by the Corporation for the purposes of the Bill and other financial and miscellaneous matters, including the use of funds for borrowing, and other matters.

22. The incorporation, repeal and amendment of Acts and Orders both general and local and the enactment of all incidental provisions.

Plans and sections of the intended works and plans of the lands intended to be taken and of the lands upon which it is intended to impose an improvement charge will on or before the 30th day of November next, be deposited with the Clerk of the Peace for the County of Derby at his office at St. Mary's Gate, Derby, and a copy of so much of the said plans, sections, and book of reference as relates to the several areas hereinafter mentioned will on, or before, the said 30th day of November be deposited as follows:—

As relates to the borough with the Town Clerk of the Borough at his office therein;

As relates to the Alvaston and Boulton Urban District with the Clerk to the Alvaston and Boulton Urban District Council at his office in the Wardwick, Derby;

As relates to the Rural District of Shardlow with the Clerk to the Shardlow Rural District Council at his office in Full Street, Derby;

As relates to the Parish of Chaddesden with the Clerk of the Parish Council of that Parish at his residence at Ivy House, at Chaddesden, in the County of Derby;

As relates to the Parish of Elvaston with the Clerk of the Parish Council of that Parish at his residence Netherlea, Ockbrook, in the County of Derby;

As relates to the Parish of Spondon with the Clerk of the Parish Council of that Parish at his residence at 2, Gladstone Road, Spondon, in the County of Derby.
