EASTBOURNE CORPORATION.

NOTICE is hereby given that application is intended to be made to Parliament in the present Session by the Mayor, Aldermen and Burgesses of the Borough of Eastbourne (hereinafter called "the Corporation" and "the borough" respectively) for an Act of which the principal subject matters are as follows:—

1. Power for the Corporation to farm all or any of the downs and downland which the Corporation have acquired or are authorised to acquire under the Eastbourne Corporation Act 1926, to purchase and sell horses, sheep and cattle and to graze them on the said downs and downland, and to make byelaws and regulations for preserving, and regulating the use of, such downs and downland.

2. The taking over by the Corporation compulsorily or by agreement and the making up and maintaining by them of part of the pleasure drive passing over Beachy Head to Birling Gap in the rural district of Eastbourne in the County of East Sussex, with power to the Corporation to demand, take and recover tolls for the use of the said pleasure drive by motor and other vehicles.

3. The extension of the Corporation's powers with regard to their motor omnibus undertaking, including power to convey dogs and to charge for so doing.

4. The employment by the Corporation of persons to take charge of motor cars and other vehicles parked on highways and to make charges for the services rendered.

5. The compulsory acquisition by the Corporation of lands and premises in the borough bounded on the west by the existing Town Hall and Police Buildings, on the south by Grove Road, on the east by number 57 Grove Road, and on the north by the gardens of numbers 23, 25, 27, 29, 31, 33 and 35 Old Orchard Road, and the extension of the Town Hall and Municipal Buildings upon such lands; and the purchase of lands for and the erection and letting of dwelling houses for the Corporation's officers and servants.

6. The enactment of further and better provision with reference to streets and buildings, and the extension of the provisions of section 14 of the Eastbourne Corporation Act 1926 so as to prohibit the placing in any unenclosed garden, forecourt, area or space or portion thereof adjoining Cornfield Place, Seaside, Langney Road, Victoria Place, Pevensey Road and Gildredge Road of temporary or permanent erections without the licence of the Corporation, with compensation for loss or damage in consequence of such prohibition.

7. The extension of the Corporation's powers with regard to town planning schemes under the Town Planning Act 1925 and any statutory modification of that Act to lands wholly or partly developed.

8. The extension of the Corporation's powers to make bye-laws, for the purpose of preventing fire or injury to persons, with respect to electrical wires apparatus and fittings, with power to the Corporation to cut off or discontinue the supply of electricity on non-compliance with the byelaws.

9. The application within the borough of the provisions of the Town Police Clauses Act 1847 with respect to the appointment and the powers duties and privileges of constables.

10. The borrowing of money and other financial provisions.

Plans of the lands intended to be taken or used compulsorily together with a book of reference to the plans will on or before the 30th day of November instant be deposited for public inspection with the Clerk of the Peace for the County of East Sussex at his office at Lewes, and on or before the said 30th day of November a copy of so much of the said plans and book of reference as relates to the borough will be deposited with the Town Clerk at the Town Clerk's Office in the borough, as relates to the rural district of Eastbourne with the Clerk to the Eastbourne Rural District Council at his office at Avenue House, Eastbourne, and as relates to the parish of East Dean, with the Clerk to the Parish Council of that parish at his office at Alfriston.

Printed copies of the Bill for the intended Act will be deposited in the Committee and Private Bill Office of the House of Commons on or before the 17th day of December next.

On and after the 21st day of December next, a copy of the Bill may be inspected at the office of the Town Clerk of the borough at the Town Clerk's Office, Town Hall, Eastbourne, and copies of the Bill may be obtained at the price of two shillings and sixpence per copy at the said office of the Town Clerk and at the offices of the undermentioned Parliamentary Agents.
