The extension of the city and county of Kingston upon Hull (hereinafter called "the city") to include parts of the urban districts and parishes of Cottingham and Hessle parts of the parishes of Anlaby, Sutton and Preston in the rural district of Sculcoates, and part of the parish of Bilton in the rural district of Skirlaugh all of which are in the East Riding of Yorkshire and are hereinafter called "the added areas." The parts of the districts and parishes proposed to be included in the city are shown on the map hereinafter mentioned and are more particularly described in the notice referred to in the final paragraph hereof.
- 2. The exclusion of the added areas from the said county and from the urban districts rural districts and parishes in which they are now included, the extension of the parish of Sculcoates in the Sculcoates Poor Law Union to include the added areas, the inclusion in the parish of Anlaby of so much of the urban district of Hessle are is not added to the city and the dissolution of the urban district of Hessle.
- 3. The enactment of provisions consequential upon and incidental or supplemental to the proposals hereinbefore mentioned, including provisions for the alteration or abolition of local government areas and authorities; provisions relating to wards of the extended city and of the parish of Sculcoates, and of the several areas affected; the election and retirement of aldermen councillors and guardians; the preparation of local government elec-tors and jurors' lists; county electoral electoral divisions; the constitution of the Sculcoates rural district council; the extension of the jurisdiction of quarter sessions, coroner, justices and others, and the exclusion of the extended city from the jurisdicexclusion tion of any other coroner; the application and modification of local Acts and Orders in force in the city and in the added areas; the prices for water and electricity; the application of adoptive Acts and other Acts, bye-laws, regulations and tables of fees; the transfer to the Corporation of property and liabilities of the county council and the district councils; elementary schools, teachers and managers; the adjustment of property and financial relations, adjustment of compensation fund under Licensing Act 1910; differential rating; the transfer or compensation of officers; superannuation; the alteration of joint committees and other bodies; the alteration of assessment areas and of the constitution of assessment funds; county insurance committee; the settlement and removal of the poor, the borrowing of money and other matters.
- 4. The abolition of the Kingston upon Hull Court of Record.
