BOOT AND SHOE REPAIRING TRADE BOARD (GREAT BRITAIN).

PROPOSAL TO VARY GENERAL MINIMUM TIME RATES, GUARANTEED TIME RATES, GENERAL MINIMUM PIECE RATES AND OVERTIME RATES FOR MALE AND FEMALE WORKERS; THE PROPOSED RATES NOT BEING DEPENDENT UPON THE "COST OF LIVING" INDEX FIGURE.

In accordance with Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour, and dated 21st April, 1927, the Boot and Shoe Repairing Trade Board (Great Britain) HEREBY GIVE NOTICE that they PROPOSE TO VARY General Minimum Time Rates, Guaranteed Time Rates, General Minimum Piece Rates and Overtime Rates for male and female workers, the proposed rates NOT being dependent upon the "Cost of Living" index figure.

Information in respect of the Trade Board's Proposal may be obtained on application to the Secretary of the Trade Board at the address given below.

Pursuant to Section 3 (5) of the Trade Boards Act, 1918, the Trade Board will consider any OBJECTIONS to the above Proposal which may be lodged with them within two months from the 4th day of December, 1928. Such objections should be in writing and signed by the person making the same (adding his or her full name and address), and should be sent to the Secretary of the Boot and Shoe Repairing Trade Board (Great Britain), 1, Whitehall Gardens, London, S.W. 1.

It is desirable that the objections should state precisely, and, so far as possible, with reasons, what is objected to.
