business to be transacted thereat, and holden in Common Room on Wednesday, 31 October 1928, present the President and all the Fellows, it was resolved (nemine contradicente) that the following amendments should be made, sealed, and submitted for the approval of The King in Council, namely:

- (1) In Stat. III (The Scholars and Exhibitioners), Clause 1, line 2, for "sixteen" there shall be substituted "twenty", and in line 6 for "£1,600" there shall be substituted "£2,000".
- (2) In Stat. V (Tuition Fund), between the first and second paragraphs, the following clause shall be inserted:

" Augmentation.

"For the purpose of further assisting the provision of reasonable stipends for the Official Fellows engaged in teaching members of the College in statu pupillari there may be contributed to the Tuition Fund out of corporate revenues, in each academic year, an aggregate sum equal to the sum of £100 multiplied by one-half of the number, or, if that number be uneven, then by one-half of the even number which is greater by one than the number of the Official Fellows of the College performing teaching duties in the College in that year. Such aggregate sum shall be distributed among all or any of such Fellows in such proportions as the President and Fellows shall determine."

The Seal of the College was affixed to the above alteration of Statutes by the President and Bursar on 22 November 1928, the consent of the University having been given by Decree of Congregation on 20 November 1928.

TENDERS FOR TREASURY BILLS.

- 1. - 7. In virtue of the provisions of Section 1 (4) of the War Loan Act, 1919, Members of the House of Commons are not precluded from tendering for these Bills.
- Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.
