Royal Highness The Duke of York, His Grace the Archbishop of Canterbury, the Lord High Chancellor of Great Britain, and the Prime Minister and First Lord of the Treasury, being authorized thereto by His Majesty's said Commission were this day pleased, upon a Representation of the Right Honourable the Lords of the Committee of Council on Education in Scotland, on His Majesty's behalf, to appoint W. W. McKechnie, Esquire, to be Secretary to the said Committee as from the 1st day of January, 1929.
