By Virtue of an Act passed in the Twenty-second year of the Reign of Her Most Gracious Majesty Queen Victoria, intituled "An Act to extend the Act of the Twenty-fourth year of King George the Third, Chapter Twenty-six for issuing Writs during any Recess of the House of Commons, whether by Prorogation or Adjournment," and of an Act passed in the 26th year of the Reign of Her Majesty Queen Victoria intituled "An Act to further limit and define the time for proceeding to Election during the Recess."

I do hereby give Notice that it hath been certified to me in writing under the hands of Two Members, serving in this present Parliament in the manner required by the said Act, that The Honourable Sir Malcolm Martin Macnaghten, K.B.E., K.C., late a Member serving in this present Parliament for the County of Londonderry, hath accepted the Office of one of the Justices of His Majesty's High Court of Justice and has been Gazetted thereto in the London Gazette dated the 18th day of December, 1928, and has thereby vacated his Seat, and that I shall issue my Warrant to the Clerk of the Crown in Northern Ireland to make out a new Writ for the Electing of a Member to serve in this present Parliament for the said County at the end of Six days after the insertion of this Notice in the London Gazette.
