## CARDIFF.

Whereas the Lord Mayor, Aldermen, and Citizens of the City of Cardiff (hereinafter called the Corporation), being the Urban Sanitary Authority for the said City have made application to the Minister of Health for the issue of a Provisional Order under Sections 297 and 303 of the Public Health Act, 1875, partially to repeal, alter or amend the Cardiff Improvement Act, 1875, and the Cardiff Corporation Act, 1894, so as:

- (1) To empower the Corporation to acquire by agreement and hold lands not immediately required which in their opinion it is desirable they should acquire and hold for or in connection with the purposes of any of their undertakings, powers or duties or for the benefit improvement or development of the City; and for the purpose of the acquisition of such lands to make payments out of the borough fund and borough rate and the general rate and general rate fund and to borrow money and to apply capital moneys arising from or in connection with the resale or exchange of or the leasing of lands so acquired as aforesaid;
- (2) To empower the Corporation to lay out and develop any lands for the time being belonging to them and on any such lands to erect and maintain buildings and to pull down and remove buildings and use or dispose of the materials thereof and to sell lease or exchange or otherwise dispose of and grant easements rights or privileges in under or over such lands or any buildings thereon and construct sewer pave flag channel and kerb streets roads and ways thereon and with respect to the exchange of lands or buildings to pay or receive money for equality of exchange and to enter into and carry into effect agreements with persons interested in any lands or buildings belonging to or to be acquired by the Corporation with respect to the reinstatement of any such persons or otherwise in relation to the matters aforesaid:
- (3) To empower the Corporation with the consent of the Minister of Health to borrow money for the purposes aforesaid;
  - (4) For the several purposes of the Application or for purposes connected with,

incidental to, or consequent on those purposes to make any such alteration or amendment of the said Local Acts, or of any other Local Act or of any Act confirming a Provisional Order made in pursuance of any of the Sanitary Acts or of the Public Health Act, 1875, and in force in the said City as may be necessary or desirable:

And whereas it is proposed that a Provisional Order should be issued in compliance with the said Application;

Notice is hereby given that A. E. H. Goddard, Esq., one of the Inspectors of the Ministry of Health, will attend at the City Hall, Cardiff, on Friday the twenty-fifth day of January, 1929, at three o'clock in the afternoon, to hold a Local Inquiry into the subjectmatter of the said Application and the proposed Provisional Order.
