The Civil Service Commissioners hereby give notice that, with the approval of the Lords Commissioners of His Majesty's Treasury, the following situations under the Admiralty, War Office and Air Ministry have been added to the Schedule appended to the Order in Council of the 22nd July, 1920, in substitution for the existing list of situations in those Departments which are included in that Schedule, viz :—

UNDER THE ADMIRALTY.

1. Situations or employments in H.M. Civil Establishments when filled, with the sanction of the Treasury, by a retired Naval, Army or Air Force Officer.
