And whereas the said Ecclesiastical Commissioners after giving full consideration to such objections have deemed right to make no alterations in such draft Scheme:

And whereas public notice of the certification to His Majesty in Council of the said Scheme and the consent thereto in writing of the Bishop of Ripon has been duly given in the manner and within the time prescribed in the Statutory Rules aforesaid:

And whereas no appeal has been made to His Majesty in Council within the period of one month after the date of the said public notice in accordance with the provisions of the said Measure against the said Scheme or any part thereof by any person who has made objection as aforesaid to the said draft Scheme:

And whereas the said Scheme has been approved on behalf of His Majesty at the Council held under the authority of the said Commission:

Now, therefore, Her Majesty The Queen, His Royal Highness The Duke of York, the Lord High Chancellor of Great Britain, and the Prime Minister and First Lord of the Treasury, being authorised thereto by His Majesty's said Commission have taken the Scheme into consideration. and do hereby, by and with the advice of His Majesty's Privy Council, on His Majesty's behalf, affirm the said Scheme and that  $\mathbf{the}$ Benefices order therein recommended bе united shallunited to the extent and for the purposes recommended in the said Scheme and further order and direct that the said Scheme and every part thereof shall be effectual in law immediately from and after the date when this Order shall have been duly published in the London Gazette pursuant to the said Measure.

And do hereby, by and with the like advice, direct that this Order be forthwith registered by the Registrar of the said Diocese of Ripon.

WHEREAS His Majesty was pleased by His Commission dated the 4th day of December, 1928, to nominate and appoint Her Majesty The Queen, His Royal Highness The Prince of Wales, K.G., K.T., K.P., G.C.S.I., G.C.M.G., G.C.I.E., G.C.V.O., G.B.E., His Royal Highness The Duke of York, K.G., K.T., G.C.M.G., G.C.V.O., the Most Reverend Father in God Cosmo Gordon, Archbishop of Canterbury, the Right Honourable Douglas McGarel, Baron Hailsham, Lord High Chancellor of Great Britain, and the Right Honourable Stanley Baldwin, Prime Minister and First Lord of the Treasury, or any three of them, during His Majesty's illness, to summon and hold on His Majesty's behalf His Privy Council, and to signify thereat His Majesty's approval of any matter or thing to which His Majesty's approval in Council is required:

And whereas the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 6th and 7th years of Her late Majesty Queen Victoria, Chapter 37, and of the Act of the 15th and 20th years of Her said late Majesty, Chapter 104, duly prepared, and laid before His Majesty in Council, a Scheme, bearing date the 13th day of December, 1928, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 6th and 7th years of Her late Majesty Queen Victoria, Chapter 37, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 104, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for constituting a separate District for spiritual purposes to be taken out of the Parish (some time District under the Parish of Manchester Division Act, 1850) of Emmanuel, Barlow Moor, within the original limits of the Parish of Manchester, in the County of Lancaster and in the Diocese of Manchester:

"Whereas we are satisfied that the said Parish of Emmanuel, Barlow Moor, is a Parish wherein or in parts whereof the provision for public worship and for pastoral superintendence is insufficient for the spiritual wants of the inhabitants thereof and it has been made to appear to us that it would promote the interests of religion that the particular portion of the said Parish of Emmanuel, Barlow Moor, which is hereinafter mentioned and described should be constituted a separate District in the manner which is hereinafter set forth:

"And whereas there is not at present within the limits of the said proposed District any consecrated Church or Chapel in use for the purposes of Divine Worship:

"And whereas we are satisfied that an adequate and permanent maintenance for the support of the Minister of the said proposed District, and when the said District shall have become a New Parish then for the support of the Incumbent thereof, will be secured as from the date of the licensing or appointment of such Minister or Incumbent by the payment of a sum of not less than £150, which will be annually provided out of the moneys received by us, the said Ecclesiastical Commissioners, under the provisions of the said Parish of Manchester Division Act, 1850:

"And whereas by a deed of conveyance dated the 8th day of November, 1928, the Right Honourable Maurice, Baron Egerton of Tatton, has conveyed to us a plot of land containing 2,442 square yards or thereabouts and situate within the said proposed separate District as
