WHEREAS His Majesty was pleased by His Commission dated the 4th day of December, 1928, to nominate and appoint Her Majesty The Queen, His Royal Highness The Prince of Wales, K.G., K.T., K.P., G.C.S.I., G.C.M.G., G.C.I.E., G.C.V.O., G.B.E., His Royal Highness The Duke of York, K.G., K.T., G.C.M.G., G.C.V.O., the Most Reverend Father in God Cosmo Gordon, Archbishop of Canterbury, the Right Honourable Douglas McGarel, Baron Hailsham, Lord High Chancellor of Great Britain, and the Right Honourable Stanley Baldwin, Prime Minister and First Lord of the Treasury, or any three of them, during His Majesty's illness, to summon and hold on His Majesty's behalf His Privy Council, and to signify thereat His Majesty's approval of any matter or thing to which His Majesty's approval in Council is required :

And whereas the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, duly prepared, and laid before His Majesty in Council, a Scheme bearing date the 13th day of December, 1928, in the words and figures following, that is to say:--

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting a transfer of the ownership of the Advowson or perpetual right of Patronage of and presentation to the Churches and Cure (hereinafter called 'the said Benefice') of Kington with Dormston, in the County of Worcester and in the Diocese of Worcester:

"Whereas the Advowson or perpetual right of Patronage of and presentation to the said Benefice of Kington with Dormston is vested for an estate in fee simple without incumbrances in Lewys Legge Yeatman, of Stock House, Sturminster Newton, in the County of Dorset, Esquire:

"And whereas the said Lewys Legge Yeatman is desirous that the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Kington with Dormston now vested in him as aforesaid, should be transferred to and be vested in the Bishop of Coventry for the time being:

"And whereas the Right Reverend Lisle, now Bishop of Coventry, is willing to accept such transfer, and in token of such his willingness he, the said Lisle, Bishop of Coventry, has executed this Scheme as hereinafter mentioned:

"And whereas the Right Reverend Ernest, Bishop of Worcester, has also executed this Scheme in token that the same transfer has that consent of the Bishop of the Diocese which by the Acts in the hereinbefore mentioned Act recited or by some or one of them is made necessary:

"And whereas the transfer of the Patronage of the said Benefice of Kington with Dormston which is hereinbefore mentioned and hereinafter recommended and proposed will in our opinion tend to make better provision for the cure of souls in the Parish or District in or in respect of which the right of Patronage or Advowson so recommended and proposed to be transferred as aforesaid arises or exists, that is to say, in the Parishes of Kington and Dormston:

"Now, therefore, with the consent of the said Lewys Legge Yeatman (in testimony whereof he has signed and sealed this Scheme) and with the consent of the said Ernest, Bishop of Worcester (in testimony whereof he has signed this Scheme and sealed the same with his Episcopal Seal), and with the consent of the said Lisle, Bishop of Coventry (in testimony whereof he has signed this Scheme and sealed the same with his Episcopal Seal), we, the Ecclesiastical Commissioners for said England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme and without any conveyance or assurance in the law other than such duly gazetted Order the whole Advowson or per-petual right of Patronage of and presentation to the said Benefice of Kington with Dormston, now vested in him, the said Lewys Legge Yeatman as aforesaid, shall be transferred to the said Lisle, Bishop of Coventry, and his successors in the same Bishopric, and shall thereupon and thenceforth become and be absolutely vested in and shall and may from time to time be exercised by the said Lisle, Bishop of Coventry, and by his successors in the same Bishopric for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or of any of them, or of any other Act of Parliament."

And whereas the said Scheme has been approved at the Council held under the authority of the said Commission:
