shall be sold and disposed of by us the said Ecclesiastical Commissioners at such time or times and in such manner in all respects as to us shall seem expedient subject to the conditions and restrictions imposed by the said Union of Benefices Measure, 1923.

(b) That the net proceeds to arise from such sale or sales after the appropriation to the Expenses Fund of the Diocese of Liverpool under the said Measure of so much of such proceeds as may in our opinion be necessary to defray the expenses attendant upon the sale or sales, the taking down of the Church, the removal of monuments (if any) and all other expenses incidental to these matters, shall be applied by us the said Ecclesiastical Commissioners as follows, that is to say (i) a capital sum sufficient to produce an income of £50 per annum shall first be set aside and transferred to the Expenses Fund established pursuant to the 32nd Section of the said Union of Benefices Measure, 1923, and the said income of £50 per annum shall be applied for the benefit of such one or more Benefices in or near the City of Liverpool and if more than one in such shares as the Bishop of Liverpool for the time being shall from time to time and at any time determine and the said income of £50 per annum shall be paid by us to the Incumbent or Incumbents of the said Benefice or Benefices by equal quarterly payments upon the 1st day of February the 1st day of May the 1st day of August and the 1st day of November in every year in each and every case upon the production of a Certificate from the Bishop of Liverpool for the time being to the effect that the Benefice in respect of which the payment is to be made is entitled for the time being either to the whole or to such share as shall correspond with the intended payment of the said income of £50 per annum and that Clerical or Lay assistance to the satisfaction of the said Bishop has been employed by such Incumbent or Incumbents during the quarter in respect of which such quarterly instalment is payable; (ii) such capital sum as may be approved by the Bishop of Liverpool and us the said Ecclesiastical Commissioners shall next be set aside towards supplementing the funds referred to in Clause 6 of this Scheme for the provision of a Parsonage House for the Incumbent of the United Benefice; (iii) such capital sum as may be approved by the Bishop of Liverpool and us the said Ecclesiastical Commissioners shall next be set aside and invested as a fund the income whereof shall be applicable towards the stipend of the Curate referred to in Clause 5 of this Scheme and (iv) the residue of such net proceeds shall be held and accumulated by us as a fund for and towards the purchase of a suitable site for and the erection of a new Church for a District within or near the City of Liverpool to be selected by the Bishop of Liverpool as the District for which such Church shall be built; and any ultimate residue after the provision of a site for and the erection of such Church shall be added to the said Expenses Fund of the Diocese of Liverpool.

"(c) That the font, communion table, sacramental plate, bells, organ and other furniture and fittings of the said Church of Liverpool, Saint Mary Magdalene, or such of them as the Bishop of Liverpool shall select, shall be transferred to the Parish Church of the United

Benefice, and any articles not so transferred shall be appropriated by the Bishop of Liverpool for use in the proposed Church of the said District or be transferred to any other Church or Chapel or Churches or Chapels within the Diocese of Liverpool which the Bishop may select: provided always that any articles that shall not be so transferred or appropriated except the font, communion table and sacramental plate, may be sold and the proceeds shall be added to the fund arising from the sale of the site and materials of the said Church of Liverpool, Saint Mary Magdalene, as aforesaid.

"9. That with the consents of the Right Honourable Stanley Baldwin, now First Lord of the Treasury (testified by his signing this Scheme), and of the said Albert Augustus, Bishop of Liverpool (testified as aforesaid), as Patrons of the said Benefice of Liverpool, Saint Simon, and with the consent of the Reverend William Horsman Royden (testified by his signing this Scheme), as Incumbent of the said Benefice of Liverpool, Saint Simon, upon the union taking effect all that part of the Parish of the said Benefice of Liverpool, Saint Mary Magdalene, which lies to the south of the middle of London Road shall be transferred for all ecclesiastical purposes to the Parish of the said Benefice of Liverpool, Saint Simon.

"Provided always that the provisions herein contained relating to the sale and disposal of the Church of Liverpool, Saint Mary Magdalene, shall not take effect until the consents and approval which by the said Union of Benefices Measure, 1923, are made requisite to the sale under the powers conferred by that Measure of the site of any Church shall be obtained to the sale and disposal hereby proposed of the said Church of Liverpool, Saint Mary Magdalene, and of the site thereof together with any ground annexed or belonging thereto.

"And provided further that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Measure, or of any other Measure of the National Assembly of the Church of England, or of any Act of Parliament."

And whereas drafts of the said Scheme have been duly published in accordance with the provisions of the said Union of Benefices Measure, 1923, and Notices have been transmitted to the persons or bodies entitled under the same Measure to receive Notice requiring any objections to such draft Scheme to be stated or transmitted in writing to the said Ecclesiastical Commissioners within the time prescribed in the Statutory Rules applicable to proceedings under the said Union of Benefices Measure, 1923:

And whereas the prescribed time has elapsed and no such objections have been so stated or transmitted to the said Ecclesiastical Commissioners:

And whereas public notice of the certification to His Majesty in Council of the said Scheme and the consent thereto in writing of the Bishop of Liverpool has been duly given in the manner and within the time prescribed in the Statutory Rules aforesaid:
