Martin as from the date of his retirement at the rate of Forty three pounds and fifteen shillings (£43 15s.) per annum; a supplementary pension of Eighteen pounds, one shilling and one penny (£18 1s. 1d.) per annum re-assessed quarterly in accordance with the variation in the Civil Service Bonus cost of living figure and subject to an overriding maximum of Eighteen pounds, one shilling and one penny (£18 1s. 1d.) per annum; and a gratuity of One hundred and fifty two pounds, fifteen shillings and seven pence (£152 15s. 7d.)."

And whereas there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 2nd day of January, 1929 (N. 3646/28) in the words following, viz. :--

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, *inter alia*, that all pay, pensions or other allowances in the nature thereof payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman or Marine therein shall be paid in such manner and subject to such restrictions, conditions and provisions as are from time to time directed by Order in Council:
