

APPOINTMENT OF A STANDING FOR HACKNEY CARRIAGES WITHIN THE METROPOLITAN POLICE DISTRICT, AND REGULATIONS TO BE OBSERVED.

By virtue of the Act 13 and 14 Victoria, chapter 7, intituled "An Act for Consolidating the Office of the Registrar of Metropolitan Public Carriages with the Office of Commissioners of Police of the Metropolis, and making other provisions in regard to the Consolidated Offices."

I, the undersigned, Commissioner of Police of the Metropolis, do hereby APPOINT a Standing for Hackney Carriages at the following place, and do make the following Regulations with regard to the Boundaries for the same, viz. :—

31st December, 1928 :—

APPOINTMENT.

AT AVENUE ROAD, HAMPSTEAD

Seven Hackney Carriages :

On the West side of roadway, commencing at Water Post situate by the Southern boundary wall of the "Swiss Cottage" Public House and extending Northward, by kerb, as far as necessary for seven carriages.

Front of vehicles towards the South.

Provided that no Hackney Carriage shall be suffered to stand across any street or thoroughfare, or opposite the end of any street or carriage-way, or upon any place where foot passengers usually cross the carriage-way.

The KING has been pleased by Royal Warrant bearing date the 19th instant to appoint Mr. Archibald Tunnock Wright to be one of the Macers of the Court of Justiciary and of the Court of Session.

Douglas King, M.P., Secretary for Mines, has appointed Mr. Henry Ralph Houston to be a Junior Inspector of Mines under the Coal Mines Acts, 1887 to 1919, and has instructed him to act also as an Inspector for the purposes of the Metalliferous Mines Regulation Acts, 1872 and 1875, and of the Quarries Act, 1894.

Under the provisions of the Mining Industry Act, 1920, and of the Factory and Workshop Act, 1901, Commodore King has further appointed Mr. Houston to be an Inspector of Factories and Workshops for the purposes of the Factory and Workshop Act, 1901, so far as it applies to quarries and pitbanks as defined in Part II of the Sixth Schedule to that Act.
