employment which is to be treated as overtime employment:—

- (a) In the case of all workers, all employment in excess of 5½ hours on a Saturday or on such other day (not being Sunday) in every week as may be agreed between employer and worker.
- (b) In the case of all workers, all employment on Good Friday, Easter Monday, Whit Monday, August Bank Holiday, Christmas Day, Boxing Day and any other Bank Holidays which may be proclaimed by Royal Proclamation.
- (c) In the case of workers employed wholly or mainly on the duties of Stockmen, all employment in excess of 60 hours in any week (including Sunday, but excluding all hours which are to be treated as overtime employment).
- (d) In the case of workers employed wholly or mainly as Carters, all employment in excess of 56 hours in any week (including Sunday, but excluding all hours which are to be treated as overtime employment).
- (e) In the case of workers other than those mentioned in (c) and (d) above,
 - (i) all employment on a Sunday,
 - (ii) all employment in excess of 50 hours in any week (excluding all hours which are to be treated as overtime employment) in summer, and
 - (iii) all employment in excess of 48 hours in any week (excluding all hours which are to be treated as overtime employment) in winter.

ORDER OF THE REGISTRAR-GENERAL IN ENGLAND.

(Dated 19th February, 1929).

Whereas, under Section 11 of the Births and Deaths Registration Act, 1837, the Registrar-General, with the approval of the Minister of Health, may divide any Union into two or more Superintendent Registrars' Districts:—

And whereas it is expedient that the Leeds Union now divided into three Registration Districts, should henceforth be divided into

two Registration Districts:

Now, therefore, I, Sylvanus Percival Vivian, C.B., Registrar-General of Births, Deaths and Marriages in England, in exercise of the power conferred by the Births and Deaths Registration Acts, 1836 to 1926, and with the sanction of the Minister of Health, do hereby order as follows:—

- 1. This Order may be cited as the Leeds Registration of Births, etc., Order, 1929, and shall come into operation on the 1st day of March, 1929.
- 2. The Bramley and Holbeck, Hunslet and Leeds Registration Districts, which together form the area of the Leeds Union, shall cease to exist and that Union shall be divided into two Superintendent Registrars' Districts, to be named Leeds North and Leeds South respectively.

3. (a) The Leeds North Registration District constituted by this Order shall consist of the existing Leeds Registration District.

- (b) The Leeds South Registration District constituted by this Order shall consist of the existing Bramley and Holbeck and Hunslet Registration Districts.
- 4. (a) Each of the existing Sub-districts in the Leeds Registration District shall form a Sub-district of the Leeds North Registration District and each of such Sub-districts shall be known by the same name as heretofore
- (b) The existing Sub-district of Bramley and Holbeck in the Bramley and Holbeck Registration District and each of the existing Sub-districts in the Hunslet Registration District shall form a Sub-district of the Leeds South Registration District and each of such Sub-districts shall be known by the same name as heretofore.
- 5. The Superintendent Registrars of the existing Leeds and the Bramley and Holbeck Registration Districts shall be respectively the Superintendent Registrars of the Leeds North and the Leeds South Registration Districts as constituted by this Order.
