

SECOND SCHEDULE.

HORNDON ON THE HILL PARISH.

Extract from Lease dated 5th January, 1870 (Ecclesiastical Commissioners No. 168678) of the Parsonage of Horndon, Essex, granted for a term of 21 years from Lady day 1869.

And further shall and will . . . deliver or cause to be delivered at the Vicarage House of Horndon aforesaid to the Vicar of Horndon for the time being and during the vacation of the Vicarage there to the said Dean and Chapter and their Successors two quarters of good sweet and merchantable Wheat and one half quarter of good sweet and merchantable Rye and one half quarter of good sweet and merchantable Barley and three quarters of good sweet and merchantable Oats accounting eight Bushels after the usual manner in the market of Horndon aforesaid to every quarter in manner and form and at the days and feasts hereinafter mentioned (that is to say) At the feast of All Saints or within six days after the same yearly one quarter of the said Wheat and the said half quarter of Rye at the feast of St. Andrew the Apostle or within six days after the same yearly the said half quarter of Barley and two quarters of the said Oats and at the feast of the purification of the Blessed Virgin Mary or within six days after the same yearly one other quarter of the said Wheat and the other quarter of the said Oats.
