## ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES.

(DATED 18TH MARCH, 1929.)

### FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1929 (No. 17).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1927, and of every other power enabling him in this behalf, hereby orders as follows:—

#### *Further Contraction of Lincolnshire Foot-and-Mouth Disease Infected Area.*

1.—(1) The Foot-and-Mouth Disease (Infected Areas) Order of 1929 (No. 14) as amended by the Foot-and-Mouth Disease (Infected Areas) Order of 1929 (No. 16) shall be read and have effect as if the Area described in the Schedule to this Order were substituted for the Foot-and-Mouth Disease Infected Area described in the Schedule to the last mentioned Order.

(2) This Article shall come into operation on the twenty-fifth day of March, nineteen hundred and twenty-nine.

#### *Release of Lincolnshire Infected Area from Restrictions.*

2. The Area described in the Schedule to this Order shall cease to be an Infected Area for the purposes of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1925, as from the first day of April, nineteen hundred and twenty-nine.

#### *Short Title.*

3. This Order may be cited as the FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1929 (No. 17).

## SCHEDULE.

### *Contracted Infected Area.*

An Area comprising:—

*In the Parts of Kesteven Division of Lincoln.*

The parish of Kirkby Green;

So much of the parishes of Metherringham, Blankney, Scopwick, Rowston, Walcot, Thorpe Tilney, Timberland and Martin as lies within the following boundary, namely:—

Commencing at a point in the parish of Scopwick where Bloxholm Lane meets the Lincoln—Scopwick road, thence northerly along the latter road as far as Prince's Street,
