ORDER OF THE REGISTRAR-GENERAL IN ENGLAND.

Whereas under Section 21 of the Births and Deaths Registration Act, 1874, the Registrar-General, with the sanction of the Minister of Health, may from time to time alter Registration Sub-districts:—

And whereas by the Stafford and Worcester (Pedmore to Wollescote) Confirmation Order, 1929, which takes effect on the 1st April, 1929, it is enacted that part of the Civil Parish of Pedmore now in the Bromsgrove Rural District and Union shall be transferred to Lye and Wollescote Urban District in Stourbridge Union and Wollescote Civil Parish:

And whereas it is expedient that certain corresponding alterations should be made in the constitution of the Registration Subdistricts hereinafter mentioned:

Now, therefore, I, Sylvanus Percival Vivian, C.B., Registrar-General of Births, Deaths, and Marriages in England, in exercise of the powers conferred by the Births and Deaths Registration Acts, 1836 to 1926, and with the sanction of the Minister of Health, do hereby order as follows:—

- 1. This Order may be cited as the Bromsgrove and Stourbridge Registration of Births, etc. (Alteration of Sub-districts) Order, 1929, and shall come into operation on the 1st April, 1929.
- 2. The Interpretation Act, 1889, applies to the interpretation of this Order as it applies to the interpretation of an Act of Parliament.
- 3. The part of the Civil Parish of Pedmore which on the 1st April, 1929, will be transferred by the above recited Order to Lye and Wollescote Urban District in Stourbridge Union, and Wollescote Civil Parish shall cease to form part of the Belbroughton Sub-district of Bromsgrove Registration District and shall be added to and form part of the Stourbridge Sub-district of Stourbridge Registration District.
- 4. The Superintendent Registrar of the existing Stourbridge Registration District shall be the Superintendent Registrar of that Registration District as extended by this Order.
- 5. The Registrar of the existing Stourbridge Sub-district of Stourbridge Registration District shall be the Registrar of that Sub-district as extended by this Order.

ORDER OF THE REGISTRAR-GENERAL IN ENGLAND.

Whereas under Section 21 of the Births and Deaths Registration Act, 1874, the Registrar-General, with the sanction of the Minister of

And whereas by the Oxford Extension Act, 1928, it is enacted, inter alia, that on the 1st April, 1929, (a) the unnamed Civil Parish (formerly part of Seacourt Civil Parish), in the Abingdon Union and (b) the parts of the Civil Parishes of Cutteslowe, Water Eaton and Wolvercot added to the City of Oxford, all in the Woodstock Union, will be transferred to the Headington Union:

And whereas by the same Act certain parts of the excluded part of the Civil Parish of Headington (now in St. Clement Sub-district of Headington Registration District) are added to Stowood, Forest Hill with Shotover and Horsepath Civil Parishes (now in Wheatley Sub-district of the same Registration District) all in Headington Union:

And whereas it is expedient that corresponding alterations should be made in the constitution of the Registration Sub-districts hereinafter mentioned.

Now, therefore, I, Sylvanus Percival Vivian, C.B., Registrar-General of Births, Deaths, and Marriages in England, in exercise of the powers conferred by the Births and Deaths Registration Acts, 1836 to 1926, and with the sanction of the Minister of Health, do hereby order as follows:—

- 1. This Order may be cited as the Abingdon, Headington and Woodstock Registration of Births, etc. (Alteration of Sub-districts) Order, 1929, and shall come into operation on the first day of April, 1929.
- 2. The Interpretation Act, 1889, applies to the interpretation of this Order as it applies to the interpretation of an Act of Parliament.
- 3. The unnamed Civil Parish (formerly part of Seacourt Civil Parish) which by the above recited Act is added to the Headington Union, shall cease to form part of the Abingdon Sub-district of the Abingdon Registration District and shall be added to and form part of the St. Clement Sub-district of Headington Registration District.
- 4. The parts of the Civil Parishes of Cutteslowe, Water Eaton and Wolvercot, which by the above recited Act are added to the Headington Union, shall cease to form part of the Woodstock Sub-district of the Woodstock Registration District and shall be added to and form part of the St. Clement Sub-district of the Headington Registration District.
- 5. The certain parts of the excluded part of the Civil Parish of Headington, which by the above recited Act are added to Stowood, Forest Hill with Shotover and Horsepath Civil Parishes shall cease to form part of the St. Clement Sub-district of Headington Registration District and shall be added to and form part of the Wheatley Sub-district of the same Registration District.
- 6. The Superintendent Registrar of the existing Headington Registration District shall be the Superintendent Registrar of that Registration District as extended by this Order.
- 7. The Registrars of the existing St. Clement and Wheatley Sub-districts of Head-
