him at the date hereof for operation upon that approved route, provided that where any person ordinarily operates less than 10 omnibuses on any approved route he shall be allowed so to operate one additional omnibus thereon; provided that nothing herein contained shall be deemed to affect or derogate from the powers of the Commissioner of Police of the Metropolis under the provisions of Section 52 of the Metropolitan Police Act, 1839, to give directions to constables for keeping order and for preventing any obstruction of the thorough-

THE ROADS ACT, 1920 COUNTY OF WESTMORLAND.

Notice is hereby given, that on the 19th day of March, 1929, the Minister of Transport made an Order under Section 7(4) of the Roads Act, 1920, in respect of certain highways in the County of Westmorland.

The Order will come into force on the 15th day of April, 1929, and is to the following effect:-

During the period of five years from the date on which the Order comes into force, no person shall, save as hereinafter provided, drive or cause to be driven on the highways specified in the First Schedule hereto any locomotive, any heavy motor car (as defined by Article II of the Heavy Motor Car Order, 1904), or any motor car with seats for more than fourteen persons exclusive of the driver.

During the period of five years from the date on which the Order comes into force, no person shall, save as hereinafter provided, drive or cause to be driven any mechanicallypropelled vehicle on the highways specified in the Second Schedule hereto:-

Nothing in the Order contained shall prevent the driving on the highways specified in the Schedules hereto (hereinafter referred to as "the said highways") of:-

Any vehicle which is being used for the purposes of agriculture in connection with land adjoining or lying near to the said highways or for the conveyance or haulage of timber felled upon such land;

Any vehicle which is being used for the conveyance of goods or merchandise to or from any house, building or other premises situate on or adjacent to the said highways;

Any vehicle which is being used in connection with the maintenance, improvement or reconstruction of the said highways, or the laying, alteration or repair in or near to the said highways of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity, or any telegraph or telephone wires, cables, posts or supports.

Nothing in the Order contained shall prevent the driving of any vehicle which is being used in connection with the quarry belonging to the Buttermere Green Slate Quarries, Limited, on the following highway included in the First Schedule hereto:-Little Langdale-Elterwater Road from the Post Office, Little Langdale, via Colwith, to the Post Office, Elterwater;

Nothing in the Order contained shall prevent the driving on the highways specified in the Second Schedule hereto of any motor car other than a heavy motor car which is being used for the conveyance of persons to or from any house, building or other premises situate on or adjacent to such highways.
