PARLIAMENTARY ELECTIONS, SCOTLAND.

THE PLACES OF ELECTION (SCOTLAND) ORDER, 1929, DATED 2ND MAY, 1929, MADE BY THE SECRETARY OF STATE UNDER SECTION 43 (16) OF THE REPRESENTATION OF THE PEOPLE ACT, 1918 (7 AND 8 GEO. V, C. 64), AMENDING THE PLACES OF ELECTION (SCOTLAND) ORDER, 1918.

Whereas by Sub-section (16) of Section 43 of the above Act it is provided that, in the case of parliamentary elections (other than an election for a university constituency) the place of election shall be a convenient room situated in such place as the Secretary for Scotland may by order from time to time determine;

And whereas in pursuance of this provision places of election were determined by the Places of Election (Scotland) Order 1918(a);

And whereas certain amendments in the provisions of that Order were made by the Places of Election (Scotland) Orders 1922(b) and 1923(c);

And whereas a further amendment in the provisions of the Places of Election (Scotland) Order, 1918, appears to me expedient;

Now therefore, I, the Right Honourable Sir John Gilmour, Bart., D.S.O., One of His Majesty's Principal Secretaries of State, do hereby order, in pursuance of the powers conferred upon me by the provision above recited as read with the Secretaries of State Act, 1926, that the Schedule to the Places of Election (Scotland) Order, 1918, shall be further amended by the substitution in Part II of Lanark for Glasgow as the Place of Election for the Lanark Division of Lanark.

This Order may be cited as the Places of Election (Scotland) Order, 1929.
