AGRICULTURAL PRODUCE (GRADING AND

Notice is hereby given that the Minister of Agriculture and Fisheries, in pursuance of the powers conferred on him by Sections 1, 2 and 3 of the Agricultural Produce (Grading and Marking) Act, 1928, proposes to make, for the purposes of the Act, the following Regulations:—

Agricultural Produce (Grading and Marking) (Apples and Pears) Regulations, 1929.

These Regulations are in substitution for and revoke the Agricultural Produce (Grading and Marking) (Apples and Pears) Regulations, 1928 (S.R. & O. No. 675).

INCOME TAX.
