Scheme shall take effect forthwith, and if on that day the said Benefice of Winterbourne Bassett only shall be vacant the union of the said Benefices of Winterbourne Bassett and Berwick Bassett shall take effect forthwith and the union of the said Benefices of Avebury and Winterbourne Monkton shall take effect upon the next avoidance thereafter of the said Benefice of Winterbourne Monkton, and if on that day the said Benefice of Winterbourne Monkton with Berwick Bassett only shall be vacant and the Incumbent of the said Benefice of Winterbourne Bassett shall consent to become the first Incumbent of the United Benefice of Winterbourne Bassett with Berwick Bassett then the unions referred to in Clauses 2 and 3 of this Scheme shall also take effect forthwith and if upon the day aforesaid neither of the said Benefices of Winterbourne Monkton with Berwick Bassett and Winterbourne Bassett shall be vacant then if the Incumbent of the said Benefice of Winter-bourne Bassett shall consent to become the first Incumbent of the United Benefice of Winterbourne Bassett with Berwick Bassett the union of the said Benefices of Winterbourne Bassett and Berwick Bassett shall take effect forthwith and the union of the said Benefices of Avebury and Winterbourne Monkton shall take effect upon the next avoidance thereafter of the said Benefice of Winterbourne Monkton. Provided that (a) if upon the day aforesaid the said Benefice of Winterbourne Bassett is full and the Incumbent thereof is not willing to become the first Incumbent of the United Benefice of Winterbourne Bassett with Berwick Bassett and if upon the said day the said Benefice of Winterbourne Monkton with Berwick Bassett is vacant or if not then vacant shall be the first of the said two Benefices of Winterbourne Monkton with Berwick Bassett and Winterbourne Bassett to fall vacant after that day then pending the taking effect of the union of the said Benefices of Winterbourne Bassett and Berwick Bassett the said Benefice of Avebury and the said Benefice of Winterbourne Monkton with Berwick Bassett shall upon the day aforesaid or upon the first avoidance thereafter of the said Benefice of Winterbourne Monkton with Berwick Bassett as the case may be, be united together and form one Benefice with Cure of Souls under the style of 'The United Benefice of Avebury with Winterbourne Monkton and Berwick Bassett' but the Parishes of the said Benefices of Avebury and Winterbourne Monkton with Berwick Bassett shall continue distinct in all respects and the union of the said Benefices of Winterbourne Bassett and Berwick Bassett shall take effect upon the next avoidance thereafter of the said Benefice of Winterbourne Bassett and (b) if upon the day aforesaid both of the said Benefices of Winterbourne Monkton with Berwick Bassett and Winterbourne Bassett are full and the Incumbent of the said Benefice of Winterbourne Bassett is not willing to become the first Incumbent of the United Benefice of Winterbourne Bassett with Berwick Bassett and if the said Benefice of Winterbourne Bassett is the first of the Benefices Winterbourne οf with Berwick Bassett and Winterbourne Bassett to fall vacant after the said day then the union of the said two Benefices of Winterbourne Bassett and Ber-

wick Bassett shall take effect upon such vacation of the said Benefice of Winterbourne Bassett and the union of the said two Benefices of Avebury and Winterbourne Monkton shall take effect upon the next vacation thereafter of the said Benefice of Winterbourne Monkton.

"6. That (a) the Parsonage House at present belonging to the said Benefice of Overton with Fyfield shall become and be the house of residence for the Incumbent of the United Benefice of Overton and Fyfield with East Kennett (b) the Parsonage House at present belonging to the said Benefice of Avebury with East Kennett shall become and be the house of residence for the Incumbent of the United ' Benefice of Avebury with Winterbourne Monkton or the United Benefice of Avebury with Winterbourne Monkton with Berwick Bassett as the case may be, (c) the Parsonage House at present belonging to the said Benefice of Winterbourne Bassett shall become and be the house of residence for the Incumbent of the United Benefice of Winterbourne Bassett with Berwick Bassett and (d) so soon as conveniently may be after the union of the said Benefices of Avebury and Winterbourne Monkton or the union of the said Benefices of Avebury and Winterbourne Monkton with Berwick Bassett as the case may be the Parsonage House at present belonging to the said Benefice of Winterbourne Monkton with Berwick Bassett and the site and appurtenances thereof and the grounds heretofore usually occupied and enjoyed therewith shall be sold and disposed of by us the said Ecclesiastical Commissioners at such time or times and in such manner in all respects as to us shall seem expedient and that the net proceeds of such sale shall be held and invested by us as part of the endowments of the United Benefice of Avebury with Winterbourne Monkton or of the United Benefice of Avebury with Winterbourne Monkton and Berwick Bassett as the case may be.

"7. That upon the union referred to in Clause 1 of this Scheme taking effect a portion of the endowments and property of the said Benefice of Avebury with East Kennett shall be annexed to the United Benefice of Overton and Fyfield with East Kennett namely all the endowments and property now belonging to the said Benefice of Avebury with East Kennett which at the date of the union of the said Benefice of Avebury with the said Benefice of East Kennett belonged to such Benefice of East Kennett together with all capital sums of money, stocks, securities and other property representing or being the produce of any sale, redemption or other conversion of the whole or any part of the endowments and property formerly belonging to the said Benefice of East Kennett as aforesaid.
