G.C.M.G., G.C.I.E., G.C.V.O., G.B.E., His Royal Highness The Duke of York, K.G., K.T., G.C.M.G., G.C.V.O., the Most Reverend Father in God Cosmo Gordon, Archbishop of Canterbury, the Right Honourable Douglas McGarel, Baron Hailsham, Lord High Chancellor of Great Britain, and the Right Honourable Stanley Baldwin, Prime Minister and First Lord of the Treasury, or any three of them, during His Majesty's illness, to summon and hold on His Majesty's behalf His Privy Council, and to signify thereat His Majesty's approval of any matter or thing to which His Majesty's approval in Council is required:

And whereas the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, duly prepared, and laid before His Majesty in Council, a Scheme bearing date the 14th day of March, 1929, in the words and figures following, that is to say:—

is to say:—
"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting a transfer of the ownership of the Advowson or perpetual right of Patronage of and presentation to the Church and Cure (hereinafter called 'the said Benefice') of Melton on the Hill in the County of York and in the Diocese of Sheffield:

"Whereas by an Indenture made the 15th day of June, 1927, between Frederick James Osbaldeston Montagu, of Shortgrove Hall, Newport, in the County of Essex, Esquire, of the first part, George Eustace Cooke Yarborough, of Campsmount, Doncaster, in the County of York, Barrister at Law, George Charlton Anne, O.B.E., of Burghwallis Hall, Askern, in the said County of York, a Squadron Leader (Retired) in Your Majesty's Royal Air Force, and Henry Stanley Bunce Greenfield, of Number 138, Salisbury House, London Wall, in the City of London, Stockbroker (hereinafter referred to as Trustees') of the second part, and the Right Reverend Leonard Hedley, Bishop of Sheffield, of the third part, after reciting that the Advowson of the said Benefice of Melton on the Hill was vested in the said Frederick James Osbaldeston Montagu in fee simple and that the Trustees were the Trustees thereof for the purposes of the Settled Land Act, 1925, it was witnessed that in consideration of the sum of Twenty-five Pounds paid to the said Trustees, the said Frederick James Osbaldeston Montagu did thereby convey unto the said Leonard Hedley, Bishop of Sheffield, the said Advowson or perpetual right of Patronage of and presentation to the said Benefice of Melton on the Hill to hold the same unto and to the use of the said Leonard Hedley, Bishop of Sheffield, and his successors in fee simple:

"And whereas the said conveyance was made with the intention of vesting the said Advowson or perpetual right of Patronage or presentation in the said Leonard Hedley, Bishop of Sheffield, in right of his See, and the parties thereto are desirous that anything which by way of further assurance or otherwise may be required effectually to carry out that intention may be done and have applied to us, the said Ecclesiastical Commissioners, that a Scheme under the Acts hereinbefore mentioned may be prepared for the said purpose and submitted to Your Majesty in Council:

"And whereas the said Frederick James Osbaldeston Montagu, George Eustace Cooke Yarborough, George Charlton Anne, Henry Stanley Bunce Greenfield, and Leonard Hedley, Bishop of Sheffield, are consenting to this Scheme, the said Leonard Hedley, Bishop of Sheffield, both as party to the said Indenture of the 15th day of June, 1927, and as Bishop of Sheffield, the Diocese wherein the said Benefice of Melton on the Hill is situate, approving of and accepting the transfer of the said Advowson or perpetual right of Patronage or presentation as required by the Acts before-mentioned or some or one of them:

"And whereas the transfer of the Patronage of the said Benefice of Melton on the Hill which is hereinbefore mentioned and hereinafter recommended and proposed will in our opinion tend to make better provision for the cure of souls in the Parish or District in or in respect of which the right of Patronage or Advowson so recommended and proposed to be transferred as aforesaid arises or exists, that is to say, in the Parish of Melton on the Hill:

"Now, therefore, with the consent of the said Frederick James Osbaldeston Montagu, George Eustace Cooke Yarborough, George Charlton Anne, and Henry Stanley Bunce Greenfield (in testimony whereof they have signed and sealed this Scheme) and with the consent of the said Leonard Hedley, Bishop of Sheffield (in testimony whereof he has signed this Scheme and sealed the same with his Episcopal Seal), we, the said Ecclesiastical Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme and without any conveyance or assurance in the law other than such duly gazetted Order the whole Advowson or perpetual right of Patronage of and pre-sentation to the said Benefice of Melton on the Hill shall be transferred to the said Leonard Hedley, Bishop of Sheffield, and his successors in the same Bishopric, and shall thereupon and thenceforth become and be absolutely vested in and shall and may from time to time be exercised by the said Leonard Hedley, Bishop of Sheffield, and by his successors in the same Bishopric for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or of any of them, or of any other Act of Parliament."
