McGarel, Baron Hailsham, Lord High Chancellor of Great Britain, and the Right Honourable Stanley Baldwin, Prime Minister and First Lord of the Treasury, or any three of them, during His Majesty's illness, to summon and hold on His Majesty's behalf His Privy Council, and to signify thereat His Majesty's approval of any matter or thing to which His Majesty's approval in Council is required:

And whereas by the Unemployment Insurance (Northern Ireland Agreement) Act, 1929, it is provided that that Act shall not come into operation unless and until His Majesty by Order in Council declares that a corresponding Act has been passed by the Parliament of Northern Ireland:

And whereas the Northern Ireland Parliament have passed an Act which may be cited as the Unemployment Insurance (Agreement) Act (Northern Ireland), 1929, and His Majesty's said Commission are satisfied that that Act is such corresponding Act as aforesaid:

Now, therefore, His Royal Highness The Prince of Wales, the Lord High Chancellor of Great Britain, and the Prime Minister and First Lord of the Treasury, being authorised thereto by His Majesty's said Commission by and with the advice of His Majesty's Privy Council on His Majesty's behalf, are pleased to declare and it is hereby declared that an Act corresponding to the Unemployment Insurance (Northern Ireland Agreement) Act, 1929, has been passed by the Parliament of Northern Ireland.

WHEREAS His Majesty was pleased by His Commission dated the 4th day of December, 1928, to nominate and appoint Her Majesty The Queen, His Royal Highness The Prince of Wales, K.G., K.T., K.P., G.C.S.I., G.C.M.G., G.C.I.E., G.C.V.O., G.B.E., His Royal Highness The Duke of York, K.G., K.T., G.C.M.G., G.C.V.O., the Most Reverend Father in God Cosmo Gordon, Archbishop of Canterbury, the Right Honourable Douglas McGarel, Baron Hailsham, Lord High Chancellor of Great Britain, and the Right Honourable Stanley Baldwin, Prime Minister and First Lord of the Treasury, or any three of them, during His Majesty's illness, to summon and hold on His Majesty's behalf His Privy

Council, and to signify thereat His Majesty's approval of any matter or thing to which His Majesty's approval in Council is required:

And whereas His Majesty, by virtue of the authority conferred on Him by the Copyright Act, 1911, 1-2 G. 5, c. 46, and having regard to the provisions of the revised Berne Copyright Convention of 1908, was pleased to make an Order in Council, dated the 24th day of June, 1912, S.R. & O. 1912 (No. 913), p. 48 (hereinafter called the Principal Order), extending the protection of the said Act to certain classes of works to which protection is guaranteed by the said Convention; including works of which the country of origin 1s Portugal or Spain:

And whereas the accession of the Republic of Portugal to the said Convention applied also to the Portuguese Colonies and the ratification of the said Convention by Spain applied to all territories dependent on the Spanish Crown:

Now, therefore, His Royal Highness The Prince of Wales, the Lord High Chancellor of Great Britain, and the Prime Minister and First Lord of the Treasury, being authorised thereto by His Majesty's said Commission in exercise of the powers conferred upon them in manner hereinbefore recited and of all other powers enabling them in that behalf, by and with the advice of His Majesty's Privy Council, on His Majesty's behalf are pleased to declare, and it is hereby declared, as follows:—

- (1) The Principal Order shall extend to the Portuguese Colonies and to the Spanish Colonies as if those Colonies were amongst the Foreign Countries therein named, subject to the following modifications:
 - (a) The provisions of Article (2), proviso (iii) (a) shall apply as if the said Colonies were included amongst the Foreign Countries named in those provisions.
 - (b) In the application of the provisions of Article (3) of the Principal Order to works of which the country of origin is any of the said Colonies the date of this Order shall be substituted for the Commencement of the Act and for the Commencement of the Principal Order.
 - (c) In the application to such works of Sections 1 (2) (d) and 19 of the Copyright Act, 1911, the date of this Order shall be substituted for the Commencement of the Act and for the passing of the Act in Sections 19 (7) and 19 (8) wherever those expressions occur.
 - (d) In the application to such works of Section 24 of the Copyright Act, 1911, the date of this Order shall be substituted for the Commencement of the Act wherever that expression occurs in Subsection (1) (a), and for the 26th July, 1910, in Subsection (1) (b).
- 2. This Order may be cited as the Berne Copyright Convention (Portuguese Colonies and Spanish Colonies) Order, 1929.

And the Lords Commissioners of the Treasury are to give the necessary orders accordingly.
