

3. The Civil Parishes of Alderton, Bawdsey and Ramsholt shall cease to form part of the Felixstowe Sub-district of Woodbridge Registration District, and shall be added to and form part of the Woodbridge Sub-district of the same Registration District.

4. The Registrar of the existing Woodbridge Sub-district shall be the Registrar of that Sub-district as extended by this Order.
