#### BOROUGH OF BRIDGWATER.

PUBLIC HEALTH ACT, 1925.

**B**Y an Order dated the 3rd day of May, 1929, the Minister of Health has consented to the adoption by the Mayor, Aldermen and Burgesses of the Borough of Bridgwater (acting as the Urban District Council) of Sections 21, 22, 44, and Sections 51 to 55 inclusive contained in Part V of the Public Health Act, 1925, to take effect on the 3rd day of May, 1929.

The above provisions are declared to be in force subject as regards Sections 51, 52, 53 and 54 to the conditions specified in the Order.
