DESTRUCTIVE INSECTS AND PESTS ACTS, 1877 to 1927.

IMPORTATION OF RAW CHERRIES ORDER OF 1929.

The Minister of Agriculture and Fisheries 'has made the above Order under the Destructive Insects and Pests Acts, 1877 to 1927.

The effect of the Order is to prohibit the landing in England or Wales after the 10th June of Italian cherries grown in the Region of Apulia, and after the 20th June of those grown in the Regions of Basilicata, Calabria and Campania. After the 30th June the importation of cherries grown in any part of Italy is entirely prohibited.

After the 15th June the landing in England or Wales of cherries grown in the southern part of France is prohibited, and after the 20th June of those grown in the central area. After the 6th July the importation of cherries grown in France is prohibited except of those grown within a small district in the North. These areas are defined in the Schedule to the Order.

Cherries imported from other European countries after the 15th June must be accompanied by certificates of origin. The certificates prescribed in the Order must be delivered to the Officer of Customs and Excise with the entry relating to the consignment.

Cherries landed without the certificates prescribed in the Order must be destroyed at the expense of the importer unless they are reexported or are disposed of in accordance with the terms of a licence issued by an Inspector of the Ministry.

An Inspector may enter any premises and open, examine and take samples of any cherries shipped or believed to have been shipped from any European country; any person wilfully obstructing or impeding an Inspector in the exercise of these powers, or failing to comply with the provisions relating to destruction or re-exportation, or with the terms of a licence, is liable to a penalty of $\pounds 10$, or in respect of a second or subsequent offence, to a penalty of $\pounds 50$.

The Order remains in force until the 30th September, 1929.

ORDER OF THE REGISTRAR GENERAL IN ENGLAND.

(Dated 27th May, 1929.)

Whereas under Section 21 of the Births and Deaths Registration Act, 1874, the Registrar General, with the sanction of the Minister of Health, may from time to time alter Registration Sub-districts:—

Now, therefore, I, Sylvanus Percival Vivian, C.B., Registrar General of Births, Deaths, and Marriages in England, in exercise of the powers conferred by the Births and Deaths Registration Acts, 1836 to 1929, and with the sanction of the Minister of Health, do hereby order as follows:—

1. This Order may be cited as the Hinckley Registration of Births, etc. (Alteration of Sub-districts) Order, 1929, and shall come into operation on the 1st day of June, 1929.

2. The Interpretation Act, 1889, applies to the interpretation of this Order as it applies to the interpretation of an Act of Parliament.

3. The part of the Civil Parish of Hinckley now in the Burbage Sub-district of Hinckley Registration District shall cease to form part of that Sub-district and shall be added to and form part of the Hinckley Sub-district of the same Registration District.

4. The part of the Civil Parish of Burbage now in the Hinckley Sub-district of Hinckley Registration District shall cease to form part of that Sub-district and shall be added to and form part of the Burbage Sub-district of the same Registration District.

5. The Registrars of the existing Subdistricts of Burbage and Hinckley shall be,
