(g) Carting coal and firewood (fuel) for worker—1s. 6d. per hour for man, horse and cart; 2s. per hour for man, two horses and cart.

(h) Garden manure supplied to worker— 4s. per cubic yard.

3. In pursuance of their said powers, the said Committee hereby order that except as in this Order provided no benefit or advantage shall be reckoned as payment of wages in lieu of payment in cash.

FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1929 (No. 22).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1927, and of every other power enabling him in this behalf, hereby orders as follows:—

Extension of Southampton Infected Area.

1. The Foot-and-Mouth Disease (Infected Areas) Order of 1929 (No. 21) shall be read and have effect as if the Area described in the Schedule to this Order were included in and formed part of the Infected Area described in the Schedule to that Order.

Short Title.
