"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or any of them or of any other Act of Parliament."

And whereas the said Scheme has been ap-

proved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His Privy Council, is pleased hereby to ratify the said Scheme, and to order, as it is hereby ordered, that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Lichfield.

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting a transfer of the ownership of the Advowson or perpetual right of Patronage of and presentation to the Church and Cure (hereinafter called 'the said Benefice') of Christ Church, Carnforth, in the County of Lancaster and in the Diocese of Blackburn:

"Whereas the Advowson or perpetual right of Patronage of and presentation to the said Benefice of Christ Church, Carnforth, is vested in the Vicar or Incumbent for the time being of the Vicarage of the Parish of Warton (near Carnforth), in the said County of Lancaster and in the said Diocese of Blackburn:
