Short Title.

3. This Order may be cited as the FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1929 (No. 24).

FIRST SCHEDULE.

An Area comprising:—

In the county of Southampton.

So much of the parishes of Hunton, Stoke Charity, Micheldever, Northington and East Stratton as lies within (*but exclusive of*) the following boundary, namely:—

Commencing at a point in the parish of Stoke Charity where Alresford Drove meets the road from Stoke Charity to Abbots Worthy at Wallers Ash, thence in a northerly direction along the latter road through Stoke Charity village to the point where the road to Hunton is met; thence following the last-mentioned road in a westerly direction to the point where it is met by the road which leads from Hunton to the Stockbridge—Basingstoke main road; thence in a north-easterly direction along the last-mentioned road and continuing in the same direction along the Stockbridge—Basingstoke main road to the point where it is crossed by the road to Micheldever Station; thence following the latter road in the direction of the railway, turning south, just before the railway is reached, along the road leading to Northbrook Farm, and, after crossing the railway, continuing in an easterly direction along the road leading past Northbrook Farm and Larkwhistle Farm as far as the Basingstoke—Winchester main road; thence in a north-easterly direction along the last-mentioned road as far as London Lodge; thence in an easterly direction along the road leading to Woodmancott as far as the Woodmancott—East Stratton parish boundary; thence in a generally southerly direction along the eastern boundary of East Stratton parish and westerly for a short distance along that parish's southern boundary to the point where Stratton Lane is met; thence southerly along that lane as far as its junction with the main road from Brown Candover to Winchester near Northington Down Farm; thence in a generally westerly direction along the last-mentioned road to Lunway's Inn and continuing in the same direction along Alresford Drove to the point of commencement.

SECOND SCHEDULE.

An Area comprising:—

In the county of Southampton.

The city and borough of Winchester;
The parishes of Weeke Without, Headbourne Worthy, Littleton and Lainston; and so much of the parishes of Abbott's Barton, Chilcomb

Without, Kings Worthy, Crawley, Hursley, and Sparsholt as lies within (*but exclusive of*) the following boundary, namely:—

Commencing at a point where the Roman Road (from Salisbury to Winchester) crosses the Weeke Without—Hursley parish boundary, thence westerly along that road as far as Burrow Road; thence in a northerly direction along the latter road via Hamgreen Cottage and the "Woodman" Inn, thence turning left at St. Stephen's Church along Westley Lane; thence following Westley Lane first in a northerly and then in an easterly direction via Upper Westley and Bushmoor Copse to its junction with the Stockbridge—Winchester main road; thence north-westerly along the last-mentioned road as far as the branch road which joins the Stockbridge—Winchester road with the road leading from Crawley to King's Somborne; thence northerly along the said branch road to its junction with the Crawley—King's Somborne road, and continuing in a north-easterly direction along the last-mentioned road as far as Crawley Pond; thence south-easterly along the road from Crawley to Littleton as far as the point where it crosses the Crawley—Littleton parish boundary east of Littleton House; thence in a generally northerly direction along the said parish boundary and the western boundary of Headbourne Worthy parish, turning easterly at Little Grove along the northern boundary of the parishes of Headbourne Worthy and King's Worthy, and following that boundary to the point where it is crossed by the road leading from Stoke Charity to Abbots Worthy; thence in a generally southerly direction along the last-mentioned road through Abbots Worthy village and Mill Lane as far as Water Lane, continuing southerly along Water Lane as far as the River Itchen; thence along that River in a southerly direction as far as the point where it intersects the Winchester city boundary just north of St. Martin's Church; thence following round the city's southern boundary, continuing afterwards along the western boundary of the parish of Weeke Without to the point of commencement.
