

of the Gas Regulation Act, 1920, for all or some of the following purposes that is to say:—

1. To empower the Company to create and issue all or any of the preference shares or stock and debenture stock which they are now authorised to create and issue as redeemable shares stock or debenture stock.
2. To make new provisions with respect to the sale of shares and stock by auction or tender.
3. To alter the limit of interest payable on money to be borrowed.
4. To make further provision with reference to the administration of the affairs of the Company including provisions as to the date of the ordinary meetings of the Company the payment of interim dividends, and annual accounts; the closing of transfer books; notices of meetings; votes of proprietors; voting by joint holders; the number, quorum qualification and disqualification and powers of the directors and the remuneration of the secretary.
5. To authorise the granting of pensions or allowances to officers and servants of the Company and their dependants.
6. To make provision for the appointment of a managing director and powers incidental thereto.
7. To make new provision as to the appointment of auditors.
8. To empower the Company to sell and lease lands not required for purposes of the undertaking.
9. To relieve the Company in certain circumstances from the obligation to comply with demands for a new or increased supply of gas.
10. To make provision as to the inspection of premises and apparatus; stand by supplies; as to mode of cutting off supplies and expenses of reconnecting disconnected supplies and the provision of valves where high pressure air or gas is used.
11. To authorise the Company to enter into agreements with any neighbouring Company or Authority for the purchase or supply of gas in bulk.
12. To make new provisions as to the authentication and service of notices by the Company.
13. To confer on the Company all powers rights privileges and authorities necessary for carrying the provisions of the intended Order into effect.
14. To incorporate or apply with or without modification all or some of the provisions of the Companies Clauses Consolidation Act, 1845, and to repeal alter or amend all or some of the provisions of the Chichester Gas Act, 1868, the Chichester Gas Order, 1881 (confirmed by the Gas Orders Confirmation Act, 1881), the Chichester Gas Order, 1906 (confirmed by the Gas Orders Confirmation (No. 1) Act, 1906), the Chichester Gas Act, 1911, and the City of Chichester Gas (Charges) Order, 1921 (S.R. & O. 1921, No. 805) and any other Act or Order affecting the Company or its undertaking.

Any local or public Authority Company or person desiring to bring before the Board of Trade any objection to the draft Order may

do so by registered letter addressed to the Director of Gas Administration, Board of Trade, Great George Street, London, S.W. 1, and despatched on or before the 30th day of September, 1929. Any such objection shall state:—

- (a) the specific grounds of objection and
- (b) the omissions additions or modifications asked for.

A copy of the objection shall be forwarded to the undersigned Solicitors and Parliamentary Agents at the same time as it is forwarded to the Board of Trade.
