Notice as to Counting of Telegrams.

The Postmaster General hereby gives notice, in pursuance of the power vested in him by the Telegraph (Inland Written Telegram) Regulations, 1920, as follows:—

(1) That where a telephone number (apart from the addressee's name or names) is used as the address of an inland telegram, the address, consisting of the name of the Exchange, number and name of town where necessary, will be reckoned and charged for as two words whatever its actual length.

Thus:---

- Jones Stafford 245 will be counted as 3 words.
- Jones Midland 245 Birmingham will be counted as 3 words.
- James Jones London Wall 4392 London will be counted as 4 words.

(2) That no charge will be made for the word "Telephone" prefixed to an ordinary address to secure telephonic delivery.

Thus :---

Telephone Jones 127 High Street Dover will be counted as 5 words.
