

CANCELLATION OF A STANDING FOR HACKNEY CARRIAGES.

First Portion. On South side of roadway, commencing at a point four yards West of Tramway Standard No. 27, and extending Eastward, by kerb, as far as necessary for four carriages.

Front of vehicles toward the West.

Second Portion. On North side of roadway, commencing at a point five yards East of the apex of railings surrounding the green of St. Olave's Parish Hall, and extending Eastward, by kerb, as far as necessary for two carriages.

Front of vehicles toward the West.

The first portion of the Standing to be fed exclusively by carriages from the second portion.
