"THE SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of Christ Church, Cinder Hill, being:-

"All that part of the Parish of Basford in the County of Nottingham and in the Diocese of Southwell, which is bounded upon the south by the Parish of Radford, upon the west partly by the Parish of Bilborough and partly by the Parish of Nuthall, upon the north west by the Parish of Bulwell, upon the north east partly by the last mentioned Parish and partly by the New Parish of Saint Aidan, Basford, all in the said County and Diocese, and upon the remaining sides, that is to say, upon the east and upon the south east by an imaginary line commencing upon the boundary which divides the said New Parish of Saint Aidan, Basford, from the said Parish of Basford at the centre of the bridge which carries the Nottingham and Mansfield Line of the London Midland and Scottish Railway across David Lane, and extending thence westward along the middle of David Lane for a distance of 7 chains or thereabouts to its junction with Queen Street and Mill Street, and extending thence first north westward and then south westward along the middle of Mill Street for a distance of 14 chains or thereabouts to its junction with Percy Street, and extending thence south eastward along the middle of Percy Street for a distance of 18 chains or thereabouts to its junction with Bar Lane, and extending thence south westward along the middle of Bar Lane for a distance of 25 chains or thereabouts to its junction with the roadway leading to High Street, and extending thence first southward to and then first south westward and then south eastward along the middle of such roadway for a distance of 12 chains or thereabouts to its junction with High Street, and extending thence south westward along the middle of High Street for a distance of 11 chains or thereabouts to its junction with Nuthall Road, and extending thence south eastward along the middle of Nuthall Road for a distance of 29 chains or thereabouts to a point opposite to the eastern end of the fence which forms the southern boundary of the close numbered 974 upon the Ordnance Survey Map of the Civil Parish of Nottingham published in the year 1915 on the scale of 25 inches to a mile and also upon the map or plan annexed to this Representation, and extending thence north westward to and along such fence and along the fence forming the southern boundary of the close numbered 973 upon the said maps for a distance in all of 17 chains or thereabouts to the south western corner of the last mentioned close on the eastern side of the mineral railway connecting the Newcastle Colliery with the London Midland and Scottish Railway and extending thence first westward to and then southward along the middle of the line of the said mineral railway for a distance of 121 chains or thereabouts to the boundary which divides the said Parish of Basford from the said Parish of Radford."

And whereas the said Representation has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Southwell.

HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 50th year of His late Majesty King George the Third, Chapter 134, of the Act of the 2nd and 3rd years of Her late Majesty Queen Victoria, Chapter 49, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 55, duly prepared, and laid before His Majesty in Council, a Representation, bearing date the 11th day of July, 1929, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 59th year of His late Majesty King George the Third, Chapter 134, of the Act of the 2nd and 3rd years of Her late Majesty Queen Victoria, Chapter 49, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 55, have prepared, and now humbly lay before Your Majesty in Council, the following Representation as to the assignment of District Chapelries to the consecrated Churches of Saint Oswald, Burneside; Saint Catherine, Crook; Saint Anne, Ings; Saint James, Staveley; and All Saints, Underbarrow, all situate in the Parish of Kendal, in the County of Westmorland and in the Diocese of Carlisle:

"Whereas it appears to us to be expedient that a District Chapelry should be assigned to each of the said Churches of Saint Oswald, Burneside; Saint Catherine, Crook; Saint Anne, Ings; Saint James, Staveley; and All Saints, Underbarrow, situate as aforesaid:

"Now therefore, with the consent of the Right Reverend Henry Herbert, Bishop of Carlisle (testified by his having signed and sealed this Representation), we, the said Ecclesiastical Commissioners, humbly represent, that it would, in our opinion, be expedient that (first) all that part of the said Parish of Kendal which is described in the First Schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, and is thereon coloured pink, should be assigned as a District Chapelry to the said Church of Saint Oswald, Burneside, situate as aforesaid, and that the same should be named 'The District Chapelry of Burneside'; (secondly) all that part of the said Parish of Kendal which is described in the Second Schedule hereunder written, all which
