RETAIL BESPOKE TAILORING TRADE BOARD (ENGLAND AND WALES).

PROPOSAL TO VARY MINIMUM RATES OF WAGES IN CERTAIN AREAS AND TO CANCEL THE MINIMUM RATES OF WAGES FOR CERTAIN CLASSES OF WORKERS IN SUCH AREAS.

In accordance with Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour, and dated 21st April, 1927, the Retail Bespoke Tailoring Trade Board (England and Wales) HEREBY GIVE NOTICE that they PROPOSE TO VARY Minimum Rates of Wages for Male and Female Workers in the Area comprising the Counties of Kent and Surrey (excluding in each case that part which lies within the Metropolitan Police District) and Sussex, and in the Area comprising the Counties of Lancashire (Eastern Part) and Westmorland, and the Urban Districts of Barnoldswick, Earby and Skipton in the County of Yorkshire, and TO CANCEL the Minimum Rates of Wages in these Areas in their application to Cutters, Trimmers and Packers.

In accordance with Section 3 (5) of the Trade Boards Act, 1918, the Trade Board WILL CONSIDER ANY OBJECTIONS to the above Proposals to Vary and to Cancel, which may be lodged with them within two months from the 3rd day of September, 1929.
