The KING has been pleased to give and grant unto Robert Andrè Llewellyn Warneford, Esq., His Majesty's Royal licence and authority to wear the Insignia of Knight of the Order of the Dannebrog, which Decoration has been conferred upon him by His Majesty the King of Denmark, in recognition of valuable services rendered by him in his consular capacity during the past thirty-six years.

The Home Secretary gives notice that in pursuance of Section 2 (1) of the Employment of Women, Young Persons and Children Act, 1920, he has made an Order authorising the employment on two day-shifts of women of 18 and young persons of 16 years of age and over in machine knitting of underwear at the works of Messrs. S. Taylor and Company (Hucknall) Limited, King Edward Street, Hucknall, near Nottingham, subject to the conditions that a worker shall not be employed in the afternoon shift in consecutive weeks and that suitable accommodation for clothing put off during working hours, adequate facilities for obtaining meals at or near the works and washing facilities shall be provided.
