## ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES.

· (DATED 14TH OCTOBER, 1929.)

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1927, and of every other power enabling him in this behalf, hereby orders as follows:—

- 1. Notwithstanding anything contained in Chapter 6 (Protection of Animals) of the Foreign Animals Order of 1910, and in Part VII (Protection of Animals) of the Importation of Canadian Cattle Order of 1923, animals shall not be carried between each first day of November and the next following thirty-first day of March (both days inclusive) on a weather deck of any vessel of the flush or spar deck type unless such deck is completely covered in to the satisfaction of the Minister.
- 2. This Order shall be read with the Orders mentioned in Article I hereof.

## ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES.

(DATED 11TH OCTOBER, 1929.)

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts,

1894 to 1927, and of every other power enabling him in this behalf, hereby orders as follows:—

Authorisation of Landing of Animals for Exceptional Purposes.

1. The landing of the animals described in the First Schedule hereto, which are intended for exceptional purposes, is hereby allowed subject to the provisions of Part II (Quarantine) of the Third Schedule to the Diseases of Animals Act, 1894, and of the Foreign Animals (Quarantine) Order of 1896, and of this Order.

Definition of Quarantine Station.

2. The premises described in the Second Schedule hereto, are hereby defined as a Foreign Animals Quarantine Station for the purpose of the detention of the animals described in the First Schedule hereto.

## Examination before Landing.

3. No such animals as aforesaid shall be landed except with a licence granted by an Inspector of the Ministry, which licence shall not be granted unless and until the animals have been examined by a Veterinary Inspector of the Ministry and certified by him to be free from symptoms of contagious disease.

Regulations applicable to the Animals on Landing.

- 4.—(1) The animals on being landed, shall forthwith be moved under the supervision of an Inspector of the Ministry of Agriculture and Fisheries from the quay to the premises described in the Second Schedule hereto, and shall be there detained for a period of twenty-eight days. During the said period the animals shall be kept separate from all other animals and no other animals shall be moved into such premises.
- (2) The animals shall not be removed from the premises described in the Second Schedule hereto otherwise than under the authority of the licence from an Inspector of the Ministry required under Article 3 (1) (Fifth) of the Foreign Animals (Quarantine) Order of 1896.
- (3) A copy of every licence authorising the movement of any animal described in the First Schedule hereto shall be forwarded to the Ministry by the Inspector who grants the licence.
