The Foot-and-Mouth Disease (Infected Areas) Order of 1929 (No. 28), shall be read and have effect as if that part of the parish of Curry Rivel, in the county of Somerset, which lies to the north and north-east of the Great Western Railway line from Durston to Yeovil (including Langport Station, the loading banks and railway company's approaches thereto), were excluded from and ceased to form part of the area described in the Schedule to that Order.
