The Home Secretary gives notice that in pursuance of Section 2 (1) of the Employment of Women, Young Persons and Children Act, 1920, he has made an Order authorising the employment on two day-shifts, of women of 18 and young persons of 16 years of age and over in the Paper Coating Department at the Card Factory of Messrs. Henry and Leigh Slater Limited, Chester Road, Macclesfield, subject to the conditions that a worker shall not be employed in the afternoon shift in consecutive weeks; that suitable cloakroom and messroom accommodation, washing facilities and facilities for sitting shall be provided and that the Secretary of State may at any time require the occupiers to make such special arrangements for the conveyance of workers living at a distance or otherwise for the welfare of such workers as may be necessary to prevent hardship.

The Home Secretary gives notice that in pursuance of Section 2 (1) of the Employment of Women, Young Persons and Children Act, 1920, he has made an Order authorising the employment on two day-shifts, of women of 18 years of age and over in punching cards from strips at the works of Messrs. John Waddington Limited, Wakefield Road, Leeds, subject to the conditions that a worker shall not be employed in the afternoon shift in consecutive weeks and that suitable accommodation for clothing put off during working hours, messroom accommodation and washing facilities shall be provided.

DANGEROUS DRUGS ACTS, 1920-1925.

WITHDRAWAL OF AUTHORITY (JOSEPH RANDOLPH MORELL MACKENZIE).

Whereas Joseph Randolph Morell Mackenzie, M.C., M.B., B.Ch., formerly of Queen's University, Belfast, lately residing at the Swan Hotel, New Street, Birmingham, has been convicted of an offence against the Dangerous Drugs Acts:

And whereas the said Joseph Randolph Morell Mackenzie cannot, in my opinion, properly be allowed to be in possession of or to supply any of the drugs or preparations to which Part III of the Dangerous Drugs Act, 1920, applies:

Now, therefore, in pursuance of the powers conferred on me by Regulation 6 of the Raw Opium Regulations, 1921, as extended by the Coca Leaves and Indian Hemp Regulations, 1928, and by Regulation 7 of the Dangerous Drugs (Consolidation) Regulations, 1928, I hereby give notice that I withdraw, as from to-day's date, from the said Joseph Randolph Morell Mackenzie, the authority granted by the said Regulations to duly qualified medical practitioners to be in possession of and supply raw opium, coca leaves and Indian hemp, and the drugs and preparations to which Part III of the Dangerous Drugs Act, 1920, applies:

And I also direct, as from the same date, that it shall not be lawful for the said Joseph Randolph Morell Mackenzie to give prescriptions for the purposes of the Dangerous Drugs (Consolidation) Regulations, 1928.
