#### TEES VALLEY WATER.

NOTICE is hereby given that application is intended to be made to Parliament in the present Session by the Tees Valley Water Board (hereinafter referred to as the "Board") for an Act of which the principal subject matters will be as follows:—

1. Construction and maintenance of certain waterworks for the purpose of more adequately and efficiently utilising and distributing the water which the Board are authorised to supply, including service reservoir in Urban District of Eston in North Riding of County of York, pumping station in Borough of Stockton-on-Tees in County of Durham, conduits or lines of pipes in Urban District of Eston, Parishes of Cotherstone, Lartington, Ovington and Barforth in Rural District of Startforth, Parishes of Caldwell and Eppley in Rural District of Richmond, Parishes of Cliffe and Manfield in Rural District of Croft and Parishes of Ingleby Barwick, Maltby, Stainton, Hemlington, West Acklam, Marton and Ormesby in Rural District of Middlesbrough in said North Riding, and Boroughs of Darlington and Stockton-on-Tees, Urban District of Barnard Castle, Parishes of Marwood, Westwick, Whorlton and Winston in Rural District of Barnard Castle, Parishes of Low Coniscliffe, Low Dinsdale, Blackwell, Haughton-le-Skerne, Morton Palms, Sadberge and Middleton St. George in Rural District of Darlington, and Parishes of Long Newton and Eggescliffe in Rural District of Stockton in County of Durham.

2. Acquisition of lands by compulsion or agreement in said areas and elsewhere and

further powers to Board with reference to acquisition, retention and disposal of lands.

3. Pressure at which water to be supplied.

4. Revision by Minister of Health of rates and charges for water.

5. Further powers to Board in connection with mains (including mains outside Board's limits) pipes, meters, etc., supply and regulation thereof, construction of tanks under streets, charges for special supplies and minimum charges in certain cases and as to inspection of premises.

6. Purchase and supply of water in bulk.

7. Protection of purity of water in works of Board and of River Tees and tributaries above intake of Board, including enforcement of Rivers Pollution Prevention Acts 1876 and 1893 either alone or jointly with Darlington Corporation.

8. Further powers with respect to administration of Board and management of their undertaking including application to Board of Provisional Order procedure under Sections 176 and 303 of Public Health Act 1875.

9. Borrowing of further moneys by Corporations of Stockton-on-Tees, Middlesbrough and Thornaby-on-Tees for purposes of Board and further provisions with reference to the finance of Board's Undertaking.

And notice is hereby further given that on or before the 30th day of November instant so much of the plans sections and book of reference relating to the said intended works and to the lands which may be taken compulsorily will be deposited for public inspection as follows (that is to say):—As relates to any County with the Clerk of the Peace for such County at his office; as relates to any Urban District or Rural District with the Clerk of the District Council of such District at his office; as relates to any Parish (other than those hereinafter mentioned) comprised in a Rural District with the Clerk of the Parish Council at his office, or, if he have no office, at his residence, or, if there be no Clerk, with the Chairman of that Council at his residence, and as relates to Parishes of Westwick, Whorlton, Lartington, Ovington, Barforth, Caldwell, Cliffe, Manfield, Low Coniscliffe, Morton Palms, Low Dinsdale, Long Newton, Ingleby Barwick, Maltby, Hemlington and West Acklam with the Chairman of the Parish Meeting of each such Parish at his residence.
