not be employed in the afternoon shift in consecutive weeks; that suitable cloakroom and messroom accommodation and facilities for sitting shall be provided and that the Secretary of State may at any time require the occupiers to make such special arrangements for the

conveyance of workers living at a distance or otherwise for the welfare of such workers as may be necessary to prevent hardship.
