*Short Title.*

3. This Order may be cited as the FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1929 (No. 36) and shall be read with the principal Order.

An Area comprising:—

*In the county of Lanark.*

The City of Glasgow. The Burghs of Airdrie, Hamilton, Rutherglen, Coatbridge, and so much of the Burgh of Motherwell and Wishaw, as is comprised within the parishes of Dalziel and Bothwell and the parishes of Cadder, New Monkland, Old Monkland, Glasgow, Rutherglen, Carmunnock, Cambuslang, Bothwell, Dalziel, Blantyre, Hamilton, East Kilbride, and Glasford.

*In the county of Stirling.*

The Burghs Denny and Dunipace and Kilsyth and the parishes of Killearn, Strathblane, Baldernock, Campsie, Kilsyth, Fintry, Balfron, Denny, and so much of the parish of Drymen as lies to the south of the railway from Alexandria to Stirling.

*In the county of Dunbarton.*

The Burghs of Dunbarton, Clydebank, Milngavie and Kirkintilloch, and the parishes of Kirkintollich, Cumbernauld, New Kilpatrick, Old Kilpatrick and Dunbarton.

*In the county of Renfrew.*

The Burghs of Paisley, Johnstone, Barrhead and Renfrew and the parishes of Erskine, Houston, Inchinnan, Renfrew, Kilbarchan, Paisley, Eastwood, Neilston, Cathcart, Mearns, Eaglesham, and so much of the parish of Lochwinnoch as lies to the south-east of the railway from Johnstone to Dalry.

*In the county of Ayr.*

The Burgh of Stewarton and the parishes of Beith, Dunlop, Fenwick and so much of the parish of Stewarton as lies to the north-east of the road from Dunlop to Fenwick via Stewarton.

AGRICULTURAL WAGES—ENGLAND.

THE AGRICULTURAL WAGES BOARD (AMENDMENT) DRAFT AND PROVISIONAL REGULATIONS, 1929, DATED 26TH NOVEMBER, 1929, MADE BY THE MINISTER OF AGRICULTURE AND FISHERIES UNDER THE AGRICULTURAL WAGES (REGULATION) ACT, 1924.

The Minister of Agriculture and Fisheries in exercise of the powers conferred on him by the Agricultural Wages (Regulation) Act, 1924, hereby makes the following Draft and Provisional Regulations:

1. As from the date of these regulations the members of the Agricultural Wages Board representing employers shall be nominated by the Council of the National Farmers' Union, and the members representing workers in agriculture shall be nominated by the Executive Committee of the National Union of Agricultural Workers and by the General Executive Council of the Transport and General Workers' Union,
