Lawrie and Company, Limited, Birstall Street, Leicester, with the conditions that subject to the convenience of individual workers no worker shall be employed in the afternoon shift in consecutive weeks and that suitable accommodation for clothing put off during working hours and messroom accommodation shall be provided.

COMPANIES ACT, 1929.

THE COMPANIES (FORMS) No. 2 ORDER, 1929, DATED NOVEMBER 30, 1929, MADE BY THE BOARD OF TRADE UNDER THE COMPANIES ACT, 1929 (19 & 20 GEO. 5, c. 23).

Whereas by Section 155 of the Companies Act, 1929, it is provided that the Transferee Company may give notice to a dissenting shareholder of the Transferor Company in the prescribed manner.

And whereas by Section 380 of the said Act the expression "prescribed" as used in Section 155 means prescribed by the Board of Trade.

Now therefore the Board of Trade do hereby prescribe as follows:—

1. The notice to be given by the Transferee Company pursuant to Section 155 shall be in Form No. 100 of the Companies (Forms) Order, 1929, (a) and shall be given to the said dissenting shareholder either personally or by sending it by registered post to him to his address registered in the books of the Transferor Company or (if he has no address within the United Kingdom so registered) to the address, if any, within the United Kingdom supplied by him to the Transferor Company for the giving of notice to him.

2. This Order may be cited as the Companies (Forms) No. 2 Order, 1929, and shall come into force on the signing hereof.
