the form of licence specified in paragraph 2 of the Schedule to that Order the word "six" were substituted for the word "four."

2. This Order shall be read as one with the Order No. 4787 referred to in Article 1 of this Order.

FOREIGN HAY AND STRAW (AMEND-MENT) ORDER OF 1929 (No. 5).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1927, and of every other power enabling him in this behalf, hereby orders as follows:—

Prohibition of Landing of Hay and Straw from Sweden.

1. Hay and straw brought from Sweden shall be subject to the prohibition of landing contained in the Foreign Hay and Straw Order of 1912, and the Foreign Hay and Straw (Amendment) Order of 1929 (No. 4) shall cease to operate accordingly.

Short Title.

2. This Order may be cited as the Foreign Hay and Straw (Amendment) Order of 1929 (No. 5).
